

¹ The communication is addressed to the Secretary-General, Mr. António Guterres; the Permanent Representative of the Netherlands to the United Nations and President of the Security Council for March 2018, Karel van Oosterom; and Members of the Security Council. It was copied to the Special Envoy of the Secretary-General for Syria, Staffan de Mistura; the High Commissioner for Human Rights, Zeid Ra'ad Al Hussein; and the President of the International Committee of the Red Cross, Peter Maurer. The communication was also signed by the Provincial Council of Rural Damascus (also on behalf of all the local councils that it represents), Alseeraj for Development and Healthcare, Baytuna Syria, Joint Medical Chamber Syria, the Local

- Administrative Councils Unit, Local Development and Small-Projects Support, the Shami Alliance, the Syrian civil defence (White Helmets) and the Day After. The communication urges the Security Council to move quickly to save the lives of the civilians in Eastern Ghouta of the Syrian Arab Republic.

- ⁴ The communication requests the President of the International Residual Mechanism for Criminal Tribunals, Judge Theodor Meron, to revise his 12 July 2018 decision prohibiting third parties from sending requests or suggestions regarding the issue of early release and commutation of sentence for genocide perpetrators convicted by the International Criminal Tribunal for Rwanda or the International Residual Mechanism for Criminal Tribunals.
