The resolutions of the Security Council, numbered in accordance with a system adopted in 1964, are published in yearly volumes of *Resolutions and Decisions of the Security Council*. The new system, which has been applied retroactively to resolutions adopted before 1 January 1965, became fully operative on that date.

Application of the People's Republic of Angola for admission to Membership in the United Nations (S/12064)

1. The PRESIDENT: On 30 April 1976 the Secretary-General, acting in accordance with rule 59 of the provisional rules of procedure circulated the application of the People's Republic of Angola for admission to membership in the United Nations [S/12064].

2. Under the further provisions of rule 59, unless the Security Council decides otherwise, such applications shall be referred by the President to the Committee on the Admission of New Members. Accordingly, unless I hear a proposal to the contrary, I shall refer the application of the People's Republic of Angola to the Committee on the Admission of New Members for examination and report.
