## Official communiqué

In accordance with rule 55 of the provisional rules of procedure of the Security Council, the following communiqué was issued by the Secretary-General and was circulated in place of a verbatim record:

"At its 1978th meeting, held in private on 7 December 1976, the Council considered the question of the recommendation for the appointment of the Secretary-General of the United Nations.

"As a result of the voting on the candidates by secret ballot, the Council unanimously adopted the following resolution:

" 'The Security Council,

*Having considered* the question of the recommendation for the appointment of the Secretary-General of the United Nations,
