NOTE

Symbols of United Nations documents are composed of capital letters combined with figures. Mention of such a symbol indicates a reference to a United Nations document.

Documents of the Security Council (symbol *S/...*) are normally published in quarterly *Supplements* of the *Official Records of the Security Council*. The date of the document indicates the supplement in which it appears or in which information about it is given.

The resolutions of the Security Council, numbered in accordance with a system adopted in 1964, are published in yearly volumes of *Resolutions and Decisions of the Security Council*. The new system, which has been applied retroactively to resolutions adopted before 1 January 1965, became fully operative on that date.

Official communiqué

In accordance with rule 55 of the provisional rules of procedure of the Security Council, the following communiqué was issued by the Secretary-General in place of a verbatim record:

"At its 2312th meeting, held in private on 11 December 1981, the Security Council considered the question of the recommendation for the appointment of the Secretary-General of the United Nations.

"As a result of the voting on the candidates by secret ballot, the Council unanimously adopted the following resolution:

The Security Council,

Having considered the question of the recommendation for the appointment of the Secretary-General of the United Nations,

Recommends to the General Assembly that Mr. Javier Pérez de Cuéllar should be appointed Secretary-General of the United Nations for a term of office from 1 January 1982 to 31 December 1986."
