- 3. I should like to draw the attention of members of the Council to document S/16271, which contains the text of a letter dated 11 January from the representative of South Africa addressed to the Secretary-General.
- 4. I understand that the Council is now prepared to vote on the draft resolution. If there are no objections I shall now put the draft resolution to the vote.

A vote was taken by show of hands.

The draft resolution was adopted unanimously [resolution 547 (1984)].

5. The PRESIDENT [interpretation from Spanish]: The Security Council has thus concluded the present stage of its consideration of the item on its agenda.
