THE SITUATION IN NAM IB IA

The PRESIDENT: The Security Council will now begin its consideration of the item on its agenda. The Security Council is meeting today in accordance with the understanding reached in the Council's consultations. Members of the Council have before them the texts of the two draft resolutions prepared in the course of the Council's consultations, contained in documents S/20399 and S/20400 in their provisional form. In this connection, I should like to draw attention to a change in the order of the paragraphs in the draft resolution contained in document S/20400. Paragraphs 3 and 4 of the draft resolution should be reversed: that is, paragraph 3 should be renumbered paragraph 4, and the original paragraph 4 should be renumbered paragraph 3.74
