The President: In accordance with the understanding reached in the Council's prior consultations, I shall take it that the Security Council agrees to extend an invitation under rule 39 of its provisional rules of procedure to Mr. Ejeviome Otobo, Director and Deputy Head of the Peacebuilding Support Office.

There being no objection, it is so decided.

I invite Mr. Otobo to take a seat at the Council table.

The Security Council will now begin its consideration of the item on its agenda. The Council is meeting in accordance with the understanding reached in its prior consultations.

Members of the Council have before them document S/2010/557, which contains the text of a draft resolution prepared in the course of the Council's prior consultations.

On behalf of Council members, I would like to thank the co-facilitators — Ambassador Heller of Mexico, Ambassador Anderson of Ireland and Ambassador Sangqu of South Africa — who successfully accomplished the task assigned to them of reviewing the arrangements set out in resolution 1645 (2005), which established the Peacebuilding Commission.

The co-facilitators' report on the review of the United Nations peacebuilding architecture is the product of extensive consultations with Member States and a wide range of stakeholders. The draft resolution before us seeks to take forward, as appropriate, the recommendations of the report, with the aim of further improving the effectiveness of the Peacebuilding Commission.

It is my understanding that the Council is ready to proceed to the vote on the draft resolution before it. Unless I hear any objection, I shall put the draft resolution to the vote now.

There being no objection, it is so decided.

A vote was taken by show of hands.

In favour:

Austria, Bosnia and Herzegovina, Brazil, China, France, Gabon, Japan, Lebanon, Mexico, Nigeria, Russian Federation, Turkey, Uganda, United Kingdom of Great Britain and Northern Ireland, United States of America.

The President: There were 15 votes in favour. The draft resolution has been adopted unanimously as resolution 1947 (2010).

The Security Council has thus concluded the present stage of its consideration of the item on its agenda.

As this may be the last Council meeting under the presidency of Uganda, I wish to take this opportunity to express my sincere thanks to all of my colleagues in the Council, who have extended most valuable cooperation to my delegation. I also wish to thank the team of the Security Council secretariat and all other United Nations Secretariat staff, who have worked behind the scenes to support the work of the presidency.
