#### **Letter dated 24 August 2021 from the Permanent Representative of Ireland to the United Nations addressed to the Secretary-General (S/2021/756)**

**The President:** In accordance with rule 37 of the Council's provisional rules of procedure, I invite the representatives of Andorra, Angola, Argentina, Australia, Austria, Bangladesh, Belgium, Bosnia and Herzegovina, Botswana, Brazil, Bulgaria, Canada, Chile, Colombia, Costa Rica, Côte d'Ivoire, Croatia, Cyprus, the Czech Republic, the Democratic Republic of the Congo, Denmark, Djibouti, the Dominican Republic, Ecuador, Egypt, Fiji, Finland, the Gambia, Georgia, Germany, Ghana, Greece, Guatemala, Hungary, Iceland, Indonesia, Italy, Japan, Jordan, Latvia, Lebanon, Lesotho, Liechtenstein, Lithuania, Luxembourg, Malaysia, Maldives, Mali, Malta, Mauritania, Montenegro, Morocco, Namibia, Nepal, the Netherlands, New Zealand, Nigeria, North Macedonia, Papua New Guinea, Peru, Poland, Portugal, Qatar, the Republic of Korea, the Republic of Moldova, Romania, San Marino, Senegal, Serbia, Slovakia, Slovenia, South Africa, Spain, Sri Lanka, the Sudan, Sweden, Switzerland, Togo, Turkey, Ukraine, the United Arab Emirates and Zimbabwe to participate in this meeting.

The Security Council will now begin its consideration of the item on its agenda.
