International Residual Mechanism for Criminal Tribunals

Before adjourning the meeting, as this is the last scheduled meeting of the Council for the month of March, I would like to express the sincere appreciation of the delegation of the United Arab Emirates to the members of the Council and to the secretariat of the Council for all the support they have given to us.

Indeed, it has been a busy and challenging month, in which we grappled with several important issues on the Council's agenda. We have been able to reach consensus several times and have delivered achievements that we can build upon. We must continue our efforts to fulfil the mandate of the Security Council and to speak in one voice.

What we achieved this month would not have been possible without the hard work, support and positive contributions of every delegation and the representatives of the Secretariat, as well as that of the interpreters and administrative and security staff.

As we end our presidency, I know I speak on behalf of the Council in wishing the delegation of the United Kingdom good luck in the month of April.

Mr. Polyanskiy (Russian Federation) (*spoke in Arabic*): As this is the last meeting of your presidency, I would like to thank and congratulate you, Madam President, at the end of your Council presidency.
