### **Credentials of representatives to the twenty-second Meeting of States Parties to the United Nations Convention on the Law of the Sea**

#### **Report of the Credentials Committee**

*Chairperson:* Ms. Rita Silek (Hungary)

1. On 5 June 2012, the twenty-second Meeting of States Parties to the United Nations Convention on the Law of the Sea appointed, on the proposal of the President, a Credentials Committee consisting of the following nine States parties: Brazil, China, Grenada, Hungary, Mozambique, New Zealand, Senegal, Switzerland and Thailand.
2. The Credentials Committee held its meeting on 5 June 2012.
3. Ms. Rita Silek (Hungary) was elected as Chairperson by acclamation.
4. The Committee had before it a memorandum by the Secretariat, dated 5 June 2012, on the status of credentials of representatives participating in the twenty-second Meeting of States Parties to the United Nations Convention on the Law of the Sea.
5. As noted in paragraph 1 of the memorandum, formal credentials issued by the Head of State or Government or by the Minister for Foreign Affairs or by a person authorized by either of them had been received by the Secretariat for the representatives of the following 96 States participating in the twenty-second Meeting of States Parties: Albania; Argentina; Australia; Austria; Bahamas; Bahrain; Bangladesh; Barbados; Belarus; Belgium; Benin; Bosnia and Herzegovina; Botswana; Brazil; Brunei Darussalam; Bulgaria; Burkina Faso; Canada; Chile; China; Comoros; Cook Islands; Costa Rica; Côte d'Ivoire; Cuba; Cyprus; Czech Republic; Djibouti; Dominican Republic; Egypt; Fiji; Finland; Gabon; Germany; Greece; Grenada; Guyana; Honduras; Iceland; India; Indonesia; Iraq; Ireland; Italy; Japan; Jordan; Kuwait; Lao People's Democratic Republic; Latvia; Lithuania; Luxembourg; Madagascar; Malaysia; Maldives; Malta; Mauritius; Mexico; Micronesia (Federated States of); Monaco; Morocco; Mozambique; Myanmar; Namibia; Netherlands; New Zealand; Nicaragua; Niue; Norway; Oman; Palau;



Panama; Poland; Portugal; Republic of Korea; Romania; Russian Federation; Saint Vincent and the Grenadines; Senegal; Seychelles; Singapore; Slovakia; Slovenia; South Africa; Spain; Sri Lanka; Suriname; Sweden; Switzerland; Thailand; the former Yugoslav Republic of Macedonia; Trinidad and Tobago; Tuvalu; Ukraine; United Kingdom of Great Britain and Northern Ireland; Uruguay; and Viet Nam.

6. As noted in paragraph 2 of the memorandum, information concerning the appointment of representatives participating in the twenty-second Meeting of States Parties had been communicated by means of facsimile or in the form of letters or notes verbales from ministries, embassies, permanent missions to the United Nations or other Government offices or authorities, or through local United Nations offices, by the following 58 States participating in the twenty-second Meeting: Algeria; Angola; Antigua and Barbuda; Armenia; Belize; Bolivia (Plurinational State of); Cameroon; Cape Verde; Congo; Croatia; Democratic Republic of the Congo; Denmark; Dominica; Equatorial Guinea; Estonia; France; Gambia; Georgia; Ghana; Guatemala; Guinea; Guinea-Bissau; Haiti; Hungary; Jamaica; Kenya; Kiribati; Lebanon; Lesotho; Liberia; Malawi; Mali; Marshall Islands; Mauritania; Mongolia; Montenegro; Nauru; Nepal; Nigeria; Pakistan; Papua New Guinea; Paraguay; Philippines; Republic of Moldova; Saint Kitts and Nevis; Saint Lucia; Samoa; Saudi Arabia; Sierra Leone; Solomon Islands; Togo; Tonga; Tunisia; Uganda; United Republic of Tanzania; Vanuatu; Yemen; and Zambia. Information concerning the appointment of representatives has also been received from the delegation of the European Union to the United Nations.

7. The Chairperson proposed that the Committee should accept the credentials of all the representatives mentioned in the memorandum by the Secretariat on the understanding that formal credentials of the representatives referred to in paragraph 2 of the Secretariat's memorandum would be communicated to the Secretariat as soon as possible. The following draft resolution was proposed by the Chairperson for adoption by the Committee:

*The Credentials Committee,*

*Having examined the credentials of the representatives to the twenty-second Meeting of States Parties to the United Nations Convention on the Law of the Sea referred to in the memorandum of the Secretariat dated 5 June 2012,*

*Accepts the credentials of the representatives concerned.*

8. The draft resolution was adopted by the Committee without a vote.

9. Subsequently, the Chairperson proposed that the Committee should recommend to the twenty-second Meeting of States Parties the adoption of a draft resolution (see para. 10 below). The proposal was adopted without a vote.

10. In the light of the foregoing, the present report is submitted to the twenty-second Meeting of States Parties to the United Nations Convention on the Law of the Sea.

**Recommendation of the Credentials Committee**

11. The Credentials Committee recommends to the twenty-second Meeting of States Parties the adoption of the following draft resolution:

**Credentials of representatives to the twenty-second Meeting of States Parties to the United Nations Convention on the Law of the Sea**

*The Meeting of States Parties to the United Nations Convention on the Law of the Sea,*

*Approves* the report of the Credentials Committee.
