1. By its resolution [72/258 B](#), the General Assembly approved an additional assessment for 2018 for the International Residual Mechanism.¹ The amounts approved by the General Assembly, as indicated in the table above, were apportioned among Member States in accordance with the provisions set out in section II and as shown in section III below.

B. Basis for credits in respect of the Tax Equalization Fund

2. Under regulation 3.2 (e) of the Financial Regulations and Rules of the United Nations, adjustments shall be made to the assessment of Member States in respect of half of the Member States' credits in the Tax Equalization Fund for the financial period estimated to be not required to meet charges for tax refunds during the calendar year and any adjustments in the estimated credits previously taken into account.

II. Apportionment of the costs of the International Residual Mechanism for Criminal Tribunals

3. The General Assembly, by its resolution [66/240](#), decided that the expenses of the Mechanism should be met through additional resources on the basis of assessed contributions and that they should be financed through a separate special account.

4. By its resolutions [52/217](#) and [52/218](#), the General Assembly decided, beginning from the budgets of 1998, to apportion half of the total budget for each international tribunal, after taking into account any cumulative surplus balance and credits from unencumbered balance, among Member States in accordance with the scale of assessments applicable to the regular budget of the United Nations and half in accordance with the rates of assessment applicable to peacekeeping operations. This method of financing has continued to be applied to all subsequent assessments for the international tribunals. The Assembly has also applied this method of financing to the International Residual Mechanism for Criminal Tribunals for 2012 and subsequent years.

5. The percentage shares shown in section III below were arrived at using the scale of assessments for 2018, adopted by the General Assembly in its resolution [70/245](#), and the updated composition of levels of contribution for peacekeeping operations for 2018 as adopted by the Assembly in resolution [70/246](#) and contained in the report of the Secretary-General ([A/70/331/Add.1](#)).
