# Thirteenth Meeting of Heads of National Drug Law Enforcement Agencies, Europe

Lisbon, 2-5 July 2019

# **Information for participants**

## I. Meeting date and venue

The thirteenth Meeting of Heads of National Drug Law Enforcement Agencies, Europe, will be held at the headquarters of the Portuguese Judiciary Police (Direção Nacional da Polícia Judiciária), Rua Gomes Freire, Lisbon, from 2 to 5 July 2019. Interpretation into the official languages of the Meeting (English, French, Russian and Spanish) will be available.

Registration will take place in the hall of the headquarters of the Portuguese Judiciary Police on Tuesday, 2 July 2019, from 8 a.m. to 12 noon.

All participants will be required to present their invitation or official communications identifying them as delegates, together with their passport or another official, photograph-bearing identity document.

#### V. Languages and documentation

The official languages of the Meeting are English, French, Russian and Spanish. Official documents of the Meeting will be made available in those official languages.

As part of the Secretariat's efforts to reduce expenditure and limit environmental impacts, only a limited number of printed copies of pre-session documents will be available at the venue. Delegates are therefore kindly requested to download the electronic versions of the documents prior to the Meeting and to bring their own printed copies if they wish.

#### VI. Visas

Participants who require a visa to attend the Meeting must contact the competent diplomatic or consular authorities of Portugal and apply for a Schengen short-stay (C) visa at least three weeks prior to their intended date of arrival in Portugal. In countries where Portugal does not have diplomatic or consular representation, visa applications can be submitted to the consular authority of a State party to the Schengen Agreement acting on behalf of Portugal in the country concerned.

## VII. Transportation

Participants are responsible for making their own arrangements for transportation to and from the airport and the Meeting venue.

Upon arriving at the airport, participants may take a taxi to their hotel. There is also a metro (subway) line and a shuttle bus service to the city centre:

- Taxi: Taxis are available outside the departure and arrival terminals. The fare from the airport to Lisbon city centre is normally around €15.
- Metro: Lisbon Airport has a metro station with a direct line to the city centre. The "Aeroporto Saldanha" line takes travellers to the city centre in about 20 minutes. The single fare price is €1.45.
- Bus: The AeroBus shuttle service provides a link between the airport and the city centre and stops near the city's main hotels. A one-way ticket costs €3.60.
