FINANCING OF THE UNITED NATIONS PEACE-KEEPING FORCES IN THE MIDDLE EAST

Review of the rates of reimbursement to the Governments of troop-contributing States

Report of the Secretary-General

I. INTRODUCTION

1. The General Assembly, by its resolution 39/70 of 13 December 1984, requested the Secretary-General to review the existing standard rates of reimbursement to the Governments of troop-contributing States, with a view to ensuring an equitable rate of reimbursement and to report on the matter to the Assembly at its fortieth session. This report is submitted in accordance with that resolution.

Standard rates of reimbursement to troop-contributing States for the cost of 2. their troops serving in the United Nations peace-keeping forces were first established by a decision of the General Assembly at its 2303rd plenary meeting of the twenty-ninth session, on 29 November 1974. These rates of reimbursement, which became effective on 25 October 1973, for troops' pay and allowances, were established at \$500 per person per month for all ranks, plus a supplementary payment of \$150 per person per month for a limited number of specialists (up to 25 per cent of logistics contingents and up to 10 per cent of other contingents). On 2 December 1977, the General Assembly, by its decision 32/416, revised the rates of reimbursement for troops' pay and allowances, effective 25 October 1977, to \$680 per person per month for all ranks, plus a supplementary payment of \$200 per person per month for specialists. A second revision of these rates was approved by the General Assembly in its resolution 35/44 of 1 December 1980. This revision, which became applicable to the United Nations Disengagement Observer Force (UNDOF) on 1 December 1980 and to the United Nations Interim Force in Lebanon (UNIFIL) on 19 December 1980, increased the rates of reimbursement to \$950 per person per month for all ranks, plus \$280 per person per month for specialists.

3. The General Assembly, at the 2440th plenary meeting of its thirtieth session on 15 December 1975, approved the principle of reimbursing troop-contributing States for the usage factor for personal clothing, gear and equipment issued to their troops for service in United Nations peace-keeping forces and requested the Secretary-General to negotiate a settlement with the troop contributors. Pursuant to this request, a reimbursement rate of \$70 per person per month was agreed upon to cover all items of personal clothing, gear and equipment and personal weaponry, including ammunition. This rate has remained unchanged.

II. TROOP COSTS

4. Currently, four States (Austria, Canada, Finland and Poland) contribute troops to UNDOF and 10 States (Fiji, Finland, France, Ghana, Ireland, Italy, Nepal, Netherlands, Norway and Sweden) contribute troops to UNIFIL.

5. Cost data for the present review of the reimbursement rates was requested from the above 13 troop-contributing States and replies were received from 12. One of the 12 submitted data in a format which did not permit its inclusion in the review. The results of the analyses of the cost information provided by 11 of the 13 troop-contributing States are set out in the annexes I, II, III and IV to the present report.

6. Annex I lists, in ascending order of magnitude, the average cost per person per month to the troop contributors in respect of pay and allowances of troops (expressed in United States dollars) as well as the absorption factor (expressed as a per cent with the latter representing that portion of the costs to the troop contributors not covered by the current rates of reimbursement. From the distribution, it may be seen that the reported average cost for pay and allowances of troops in 1984/85 ranged between \$708 and \$3,674 per person per month with an overall average cost of \$1,905 and a median cost of \$1,615. The comparable figures for 1980 ranged from \$1,201 to \$3,341, with an overall average cost of \$2,037 and a median cost of \$1,944. 1/

7. Annex II provides a distribution, in ascending order, of the average cost per person per month of the usage factor for troops' personal clothing, gear and equipment and personal weaponry (including ammunition) together with the absorption factors indicating the percentage of the costs to the troop-contributing States not covered by the current rate of reimbursement of \$70. The reported average cost per person per month in 1984/85 ranged from \$48 to \$473, with an overall average cost of \$139 and a median of \$81.

8. A composite of the average costs per person per month for the items covered by the standard rates of reimbursement, i.e. pay and allowances, personal clothing, gear and equipment and personal weaponry (including ammunition) is shown in annex III. These composite costs, listed in ascending order of magnitude, indicate a cost range from \$789 to \$3,948. The overall average cost per person per month amounts to \$2,044 with a median cost of \$1,663.

III. CONSIDERATIONS

9. Inflation and currency exchange rate fluctuations are the two main factors that could change the level of compensation based on the reimbursement rates effective December 1980. Consequently, this review focused on determining the extent to which these two factors had contributed to escalating troop costs and thus adversely affected, in real terms, the relationship between these costs and the existing standard rates of reimbursement.

10. The changes in the rates of inflation and of currency exchange for the period between 1980 and 1984 for the 13 troop contributors enumerated in paragraph 4 above are indicated in annex IV. They show, after adjusting for the impact of inflation since 1980, that at the end of 1984 the value of the United States dollar (the currency of reimbursement) had increased in relation to the national currencies of 10 of the troop contributors. In the remaining three cases the value of the United States dollar had declined <u>vis-à-vis</u> their national currencies. Overall, the changes in the value of the United States dollar over the period 1980 to 1984, in respect of the 13 national currencies ranged from a decrease in value from 28.2 per cent to an increase of 435.3 per cent. For the 11 countries included in the review, the overall average increase in the value of the United States dollar was 19.6 per cent. When all 13 troop-contributing countries are considered, the average increase was 50.4 per cent.

11. As regards escalating troop costs, <u>per se</u>, it is not possible to determine precisely the escalation that has affected such costs for any one troop contributor since December 1980. The data submitted for the 1980 review did not permit the identification of the Member States which had supplied data; moreover, the composition of the troop-contributing States in UNIFIL between 1980 and 1984/85 has changed.

IV. CONCLUSIONS AND RECOMMENDATIONS

12. The changes in the currency exchange rates of 1984 over 1980 in terms of the national currencies of the troop contributors in relation to the United States dollar have been such that they have, in most cases, offset the adverse effects of inflation. Hence, it would appear that the current standard rates of reimbursement continue to provide a fair and reasonable compensation to troop contributors for troop costs and that a basis does not exist, at the present time, to warrant an adjustment to the rates of reimbursement.

13. At the time of the initial establishment of standard rates of reimbursement, it was recognized that certain troop-contributing States would not be fully reimbursed for their entire expenses of providing troops to the United Nations peace-keeping forces, based on an equitable standard rate of reimbursement formula. However, all Member States should receive at least that portion which was paid to their troops as actual overseas allowances.

14. Based on the data provided by the ll troop-contributing States included in the review, 10 are currently absorbing between 11.7 per cent and 72.2 per cent, for an

average of 34.3 per cent, in respect of pay and allowances paid to their troops. In 1980, when the present rates of reimbursement were established, the absorption factors ranged from 18.6 per cent to 69.5 per cent with an average of 45.9 per cent.

15. Should there be changes in the currency exchange and/or inflation rates that would drastically affect the existing levels of compensation for troop costs thereby increasing the absorption factor borne by the troop-contributing States, it would be desirable to ensure that measures are taken to redress the situation within a reasonable time. It is therefore proposed that a review of the rates of reimbursement be undertaken as and when changes in currency exchange and/or inflation rates so dictate.
