# 41/321. Election of a member of the International Court of Justice

The General Assembly at its 103rd plenary meeting, on 14 September 1987, and the Security Council at its 2752nd meeting, on the same date, proceeded independently of one another to elect, in accordance with Articles 2 to 4, 7 to 12, 14 and 15 of the Statute of the International Court of Justice, rules 150 and 151 of the rules of procedure of the Assembly and rules 40 and 61 of the provisional rules of the Council, a member of the Court for a term expiring on 5 February 1991 to fill the vacancy caused by the death of Mr. Guy LADREIT DE LACHARRIÈRE (France).<sup>1</sup> The following person was elected:
