

Fourth report of the Credentials Committee

Chair: Carl Grainger (Ireland)

- 1. At the organizational meeting of the intergovernmental conference on an international legally binding instrument under the United Nations Convention on the Law of the Sea on the conservation and sustainable use of marine biological diversity of areas beyond national jurisdiction held from 16 to 18 April 2018, the conference decided that the rules of procedure and the established practice of the General Assembly, as modified by Assembly resolution 72/249, would apply mutatis mutandis to the conference.
- 2. Rule 28 of the rules of procedure of the General Assembly provides as follows:

 A Credentials Committee shall be appointed at the beginning of each session. It shall consist of nine members, who shall be appointed by the General Assembly on the proposal of the President. The Committee shall elect its own officers. It shall examine the credentials of representatives and report without delay.
- 3. At the first plenary meeting of the organizational meeting, held on 16 April 2018, the conference decided that the composition of the Credentials Committee of the conference would follow the composition of the Credentials Committee of the seventy-second session of the General Assembly and appointed Cabo Verde, China, Dominica, Indonesia, Ireland, the Russian Federation, Uganda, the United States of America and Uruguay as members of the Credentials Committee for the entire duration of the conference.
- 4. The Credentials Committee held its fourth meeting on 15 March 2022.
- 5. The Committee had before it a memorandum by the Secretary-General dated 14 March 2022 concerning the credentials of representatives to the fourth session of





the conference. The representative of the Office of Legal Affairs made a statement related to the memorandum.

- 6. As indicated in paragraph 1 of the memorandum of the Secretary-General, formal credentials of representatives to the fourth session of the conference, in the form required under rule 27 of the rules of procedure of the General Assembly, had been submitted to the Secretary-General, as at the time of the meeting of the committee, by the European Union and the following 51 States: Angola, Argentina, Austria, Bahamas, Brazil, Canada, Chile, China, Cook Islands, Costa Rica, Croatia, Cyprus, Denmark, Ecuador, Eritrea, Estonia, Finland, France, Germany, Greece, Guatemala, Holy See, Indonesia, Iran (Islamic Republic of), Ireland, Italy, Japan, Lithuania, Malta, Mexico, Monaco, Nepal, Netherlands, Niger, Peru, Philippines, Portugal, Republic of Korea, Saudi Arabia, Singapore, Slovakia, Slovenia, South Africa, Spain, State of Palestine, Sweden, Switzerland, Thailand, United Kingdom of Great Britain and Northern Ireland, United States of America and Viet Nam.
- As indicated in paragraph 2 of the memorandum, information concerning the 7. appointment of representatives to the fourth session of the conference had been communicated to the Secretary-General, as at the time of the meeting of the committee, by means of a facsimile communication from the Head of State or Government or the Minister for Foreign Affairs, or by means of a letter or note verbale from the mission concerned, by the following 68 States: Algeria, Australia, Bangladesh, Barbados, Belgium, Belize, Bolivia (Plurinational State of), Botswana, Brunei Darussalam, Bulgaria, Cabo Verde, Cambodia, Colombia, Côte d'Ivoire, Cuba, Czechia, Democratic Republic of the Congo, Djibouti, Dominican Republic, Egypt, El Salvador, Fiji, Gabon, Gambia, Ghana, Grenada, Iceland, India, Kenya, Kiribati, Latvia, Lebanon, Madagascar, Malaysia, Maldives, Marshall Islands, Mauritius, Micronesia (Federated States of), Mongolia, Morocco, Nauru, New Zealand, Nicaragua, Oman, Pakistan, Palau, Panama, Papua New Guinea, Paraguay, Poland, Romania, Russian Federation, Saint Vincent and the Grenadines, Samoa, Senegal, Seychelles, Sierra Leone, Sri Lanka, Suriname, Tonga, Trinidad and Tobago, Tunisia, Turkey, Tuvalu, United Republic of Tanzania, Uruguay, Venezuela (Bolivarian Republic of) and Zimbabwe.
- 8. The Chair of the Credentials Committee recommended that the Committee accept the credentials of the representatives of the European Union and the States listed in paragraphs 1 and 2 of the above-mentioned memorandum on the understanding that formal credentials of representatives of States referred to in paragraph 2 of the memorandum, as well as other States that had not yet submitted formal credentials, where applicable, would be communicated to the Secretary-General as soon as possible.
- 9. The Committee had before it two communications concerning the representation of Myanmar at the fourth session of the conference, indicating different individuals as representatives to the fourth session of the conference. The first was dated 3 March 2022 from the Permanent Representative of Myanmar to the United Nations in New York. The second was dated 14 March 2022 from the Ministry of Foreign Affairs of Myanmar. Acknowledging the report of the Credentials Committee of the General Assembly at its seventy-sixth session (A/76/550), the Chair proposed that the Committee defer its decision on the credentials pertaining to the representatives of Myanmar at the fourth session of the conference. The proposal was adopted without a vote.
- 10. The Chair proposed the following draft resolution for adoption by the Committee:

The Credentials Committee,

Having examined the credentials of the representatives to the fourth session of the intergovernmental conference on an international legally binding instrument under the United Nations Convention on the Law of the Sea on the conservation and sustainable use of marine biological diversity of areas beyond national jurisdiction,

Accepts the credentials of the representatives referred to in paragraphs 1 and 2 of the memorandum of the Secretary-General, as updated.

- 11. The draft resolution proposed by the Chair was adopted without a vote.
- 12. The Chair then proposed that the Committee recommend to the conference the adoption of a draft resolution entitled "Credentials of representatives to the intergovernmental conference on an international legally binding instrument under the United Nations Convention on the Law of the Sea on the conservation and sustainable use of marine biological diversity of areas beyond national jurisdiction" (see para. 14 below). The proposal was adopted without a vote.
- 13. In the light of the foregoing, the present report is submitted to the conference.

Recommendation of the Credentials Committee

14. The Credentials Committee recommends to the conference the adoption of the following draft resolution:
