# Participation of intergovernmental organizations in the Meetings of States Parties to the United Nations Convention on the Law of the Sea as observers

### Note by the secretariat

- 1. At its twenty-sixth Meeting, the Meeting of States Parties to the United Nations Convention on the Law of the Sea reviewed its practice under rule 18, paragraph 3, of the Rules of Procedure for Meetings of States Parties (SPLOS/2/Rev.4), which provides that the specialized agencies of the United Nations system, the International Atomic Energy Agency and other intergovernmental organizations that are invited to the Meeting may also participate as observers. The Meeting decided, in this connection, to align its practice concerning the participation of intergovernmental organizations as observers in its Meetings with that of the subsidiary bodies of the General Assembly.
- 2. In view of the Meeting's decision, the present note draws upon the practice of ocean-related subsidiary bodies of the General Assembly. It is noted that these subsidiary bodies routinely extend an invitation to specialized agencies and related organizations of the United Nations, intergovernmental organizations having received a standing invitation to participate as observers in the work of the Assembly pursuant to its relevant resolutions and intergovernmental organizations with competence in ocean affairs (see SPLOS/303, paras. 113–114, and SPLOS/316, para. 110).
- 3. Intergovernmental organizations having received a standing invitation to participate as observers in the sessions and the work of the General Assembly are listed in a document of the Assembly issued at every session (see A/INF/72/5/Rev.1 for the latest list). It is noted that the Assembly may decide in its future sessions to invite additional intergovernmental organizations to participate in the sessions and the work of the Assembly as observers.
- 4. The annex to the present note contains a list of intergovernmental organizations with competence in ocean affairs that have not received a standing invitation to participate as observers in the sessions and the work of the General Assembly.

Pursuant to its decision at the twenty-sixth Meeting and in order to align its practice concerning the participation of intergovernmental organizations as observers in its Meetings with that of ocean-related bodies of the General Assembly, the Meeting may wish to consider extending a standing invitation to those intergovernmental organizations with competence in ocean affairs as listed in the annex to the present note and as updated by the secretariat, as appropriate, in addition to the specialized agencies and related organizations of the United Nations and the intergovernmental organizations having received a standing invitation to participate as observers in the sessions and the work of the Assembly.
