Land violations committed in June 2021

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
1 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 15 in Alma al-Sha'b, 7 in Duhayrah, 2 in Bustan, 9 in Yarun, 29 in Mays al-Jabal, 11 in Arab al-Luwayzah and 7 in Hula.
	0715	An Israeli enemy patrol comprising 16 individuals in military clothing approached from occupied Lebanese territory, opposite the town of Udaysah, near point TP36(2), and conducted a foot patrol along the dirt road, proceeding as far as the area near point TP37. At 0750 hours, they opened a metal gate in the technical fence and 10 members of the patrol took up positions inside the emplacement situated at the site. Meanwhile, the other six members took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0730	From occupied Palestinian territory, opposite the town of Wazzani, near pillar No. 40, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	0930	In occupied Palestinian territory, opposite the town of Markaba, at Israeli enemy position <i>shin</i> -23, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory until 1300 hours.
	1140	In occupied Palestinian territory, opposite the town of Mays al-Jabal, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	1200	Opposite the town of Udaysah, near point TP36(2), an Israeli enemy civilian bus approached from occupied Lebanese territory. Some 25 individuals in civilian clothing disembarked, scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1300 hours.
	1330	An Israeli enemy patrol comprising a Merkava tank, two troop carriers and a pickup truck stopped in the occupied Shab'a Farms, in the locality of Birkat al-Naqqar. Camouflaging smoke was released from the tank, the cannon of which was pointed towards Lebanese Army soldiers.
	2140	In occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy's Jabal al-Tayyarah position, Israeli enemy soldiers pointed a searchlight towards Lebanese territory as follows: for one minute at 2140 hours, for one minute at 2150 hours and for one minute at 2153 hours.
2 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 11 in Alma al-Sha'b, 8 in Mays al-Jabal, 8 in Duhayrah, 6 in Bustan, 18 in Yarun, 14 in Arab al-Luwayzah and 3 in Hula.
	0630	Explosions of unknown origin were heard inside the occupied Shab'a Farms.

	0720	An Israeli enemy patrol comprising 16 individuals in military clothing approached from occupied Lebanese territory, opposite the town of Udaysah, near point TP36(2), and conducted a foot patrol along the dirt road, proceeding as far as the area near point TP37. At 0750 hours, they opened a metal gate in the technical fence and 10 members of the patrol took up positions inside the emplacement situated at the site. Meanwhile, the other six members took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	1000	In occupied Palestinian territory, opposite points B31 and BP13, Israeli enemy soldiers installed a pole atop a concrete block. Attached to the pole were a solar panel, an electric lamp and a box housing a camera, which was pointed towards Lebanese territory.
3 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 10 in Duhayrah, 14 in Bustan, 11 in Yarun, 11 in Arab al-Luwayzah, 13 in Mays al-Jabal and 1 in Hula.
	0730	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), a 16-soldier Israeli enemy patrol conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and 10 patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory. Later, a trench excavator was brought in and used to continue excavating an existing trench, and to lay pipes in that trench and then backfill it. Work ended at 1600 hours, and all left in the direction of occupied territory.
	1630	Opposite the town of Sahl al-Khiyam, near point B90, three Israeli enemy civilian vehicles approached from occupied Palestinian territory. Some six individuals in civilian clothing disembarked, scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1720 hours.
4 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 28 in Alma al-Sha'b, 6 in Mays al-Jabal, 7 in Duhayrah, 8 in Bustan, 15 in Yarun and 10 in Arab al-Luwayzah.
5 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 6 in Duhayrah and 9 in Bustan.
6 June	0715	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), a 16-soldier Israeli enemy patrol conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and 10 patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory. Later, a trench excavator was brought in and used to continue excavating an existing trench, and to lay pipes in that trench and then backfill it. Work ended at 1610 hours, and all left in the direction of occupied territory.
7 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 30 in Alma al-Sha'b, 14 in Duhayrah, 2 in Bustan, 11 in Arab al-Luwayzah and 13 in Mays al-Jabal.

	0700	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), a 16-soldier Israeli enemy patrol conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and 10 patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory. Later, a trench excavator was brought in and used to continue excavating an existing trench, and to lay pipes in that trench and then backfill it. Work ended at 1530 hours, and all left in the direction of occupied territory.
8 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 19 in Alma al-Sha'b, 7 in Mays al-Jabal, 14 in Duhayrah, 8 in Yarun and 10 in Arab al-Luwayzah.
	0700	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), a 12-soldier Israeli enemy patrol conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and six patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory. Later, a pickup truck, a trench excavator and five workers arrived and placed four concrete manholes in an existing trench and then backfilled it. Work ended at 1555 hours, and all left in the direction of occupied territory.
	1400	An Israeli enemy patrol comprising a Merkava tank, two troop carriers and a pickup truck stopped in the occupied Shab'a Farms, in the locality of Birkat al-Naqqar. Camouflaging smoke was released from the tank, the cannon of which was pointed towards Lebanese territory.
9 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 22 in Alma al-Sha'b, 7 in Mays al-Jabal, 9 in Duhayrah, 6 in Bustan, 21 in Yarun, 21 in Amra and 16 in Arab al-Luwayzah.
	0700	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), a 16-soldier Israeli enemy patrol conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and 10 patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory. At 0800 hours, two trench excavators, a civilian vehicle and four workers reached the area of point TP37 and continued excavating an existing trench. They placed three concrete manholes in the trench and then backfilled it. Work ended at 1540 hours, and all left in the direction of occupied territory, closing the gate behind them.
	1415	In occupied Palestinian territory, opposite the town of Alma al-Sha'b, at the Israeli enemy's Hanita East 2 position, Israeli enemy soldiers pointed the cannon of a Merkava tank and their weapons towards Lebanese territory until 1710 hours.
	1500	In occupied Palestinian territory, opposite the town of Ramiyah and point BP10(1), Israeli enemy soldiers pointed their weapons towards Lebanese Army soldiers.

	1655	In occupied Palestinian territory, opposite the town of Ramiyah and point BP10(1), Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
10 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 8 in Alma al-Sha'b 23 in Yarun, 10 in Arab al-Luwayzah and 11 in Mays al-Jabal.
	0700	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), a 16-soldier Israeli enemy patrol conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and 10 patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory. At 0800 hours, two trench excavators, a civilian vehicle and four workers arrived and continued excavating an existing trench. They placed two concrete manholes in the trench and then backfilled it. Work ended at 1610 hours, and all left in the direction of occupied territory, closing the gate behind them.
	1640	As the civilian Abdullah al-Shihab was farming in Lebanese territory, outside the town of Abbasiyah (Hasbaya), near position 4-28 of the Spanish contingent of the United Nations Interim Force in Lebanon (UNIFIL), a patrol consisting of two Humvee vehicles belonging to the Israeli enemy stopped on the opposite side. Some seven soldiers disembarked and hurled two smoke bombs in the direction of the aforementioned town, but no one was harmed. They patrol left in the direction of occupied territory at 1655 hours.
11 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 8 in Bustan, 8 in Duhayrah, 26 in Yarun, 9 in Mays al-Jabal, 6 in Amra and 13 in Arab al-Luwayzah.
	1300	Opposite point TP37, Udaysah, an Israeli enemy civilian four-wheel drive vehicle approached from Palestinian territory. Two individuals in civilian clothing disembarked, scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1340 hours.
12 June	1730	In Sahl al-Khiyam, opposite point B90, as several farmers were present in Lebanese territory, an Israeli enemy patrol consisting of two Wrangler vehicles and a Humvee vehicle stopped on the opposite side, in occupied Palestinian territory. Some seven individual in military clothing disembarked and fired into the air towards Lebanese territory and hurled two smoke bombs that fell in Lebanese territory. No one was harmed in the incident. They patrol left in the direction of occupied territory at 1800 hours.
13 June	0730	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), a 16-soldier Israeli enemy patrol conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and 10 patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory. At 0800 hours, two trench excavators and four workers reached the area of point TP37 and levelled the dirt road that runs next to the technical fence and placed plastic pipes inside the concrete manholes. Work ended at 1640 hours, and all left in the direction of occupied territory, closing the gate behind them.

14 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 13 in Duhayrah, 14 in Mays al-Jabal, 6 in Amra and 4 in Arab al-Luwayzah.
	0710	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), a 16-soldier Israeli enemy patrol conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and 10 patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory. At 0800 hours, a trench excavator and a truck loaded with basecourse material arrived. The material was dumped from the truck onto the dirt road four times in succession and the excavator was used to level it. Work ended at 1530 hours, and all left in the direction of occupied territory.
	1000	Opposite the town of Kafr Kila, an Israeli enemy civilian bus approached from the enemy's Jabal al-Tayyarah position in occupied Palestinian territory. Some 30 individuals in civilian clothing disembarked, scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1040 hours.
	1145	In occupied Palestinian territory, opposite the town of Mays al-Jabal, Israeli enemy soldiers pointed a MAG machine gun mounted on a Humvee vehicle towards Lebanese territory.
15 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 16 in Alma al-Sha'b, 11 in Duhayrah, 18 in Yarun, 2 in Hula, 5 in Amra and 6 in Mays al-Jabal.
	0630	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), an Israeli enemy patrol comprising 14 individuals in military clothing arrived and conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and 10 patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory. At 0800 hours, a trench excavator was brought to the area of point TP37 and used to level the dirt road that runs next to the technical fence. All left in the direction of occupied territory at 1550 hours, closing the gate behind them.
	0830	In occupied Palestinian territory, opposite the Shab'a Farms, Israeli enemy soldiers photographed Lebanese Army soldiers.
	1040	Opposite the town of Kafr Kila, four Israeli enemy buses approached from the enemy's Jabal al-Tayyarah position in occupied Palestinian territory. Some 60 individuals in civilian clothing disembarked, scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1130 hours.
16 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 7 in Duhayrah, 2 in Bustan, 25 in Yarun, 8 in Amra and 12 in Arab al-Luwayzah.
	0630	Explosions of unknown origin were heard inside the occupied Shab'a Farms.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
	0715	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), an Israel enemy patrol comprising 16 individuals in military clothing arrived and conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and 10 patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory. At 0800 hours, eight trucks loaded with basecourse material arrived and dumped their loads at the site. At 0810 hours, an excavator was brought in and used to level the basecourse material all along the dirt road. At 1100 hours, a construction vehicle was brought in and used to raise a pole mounted with a surveillance camera, which was then pointed towards Lebanese territory. At 1200 hours, the camera was lowered and the construction vehicle was taken away in the direction of occupied territory. Work ended at 1600 hours, and the personnel, the trucks and the excavator left in the direction of occupied territory.
	1150	In occupied Palestinian territory, opposite the town of Udaysah, at the Panorama point, as Israeli enemy personnel carried out maintenance work on surveillance cameras, the members of an enemy patrol hurled two smoke bombs that fell inside Lebanese territory. At 1200 hours, the work ended and the enemy soldiers left in the direction of occupied territory.
	1305	As a shepherd was present in Sahl al-Khiyam, near point B92, an Israeli enemy patrol arrived from occupied territory and hurled three smoke bombs, all of which fell in Lebanese territory. No one was harmed in the incident. They patrol left in the direction of occupied territory at 1335 hours.
17 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 19 in Alma al-Sha'b, 11 in Duhayrah, 2 in Bustan, 26 in Yarun, 8 in Mays al-Jabal, 3 in Amra and 12 in Arab al-Luwayzah.
	0615	Explosions of unknown origin were heard inside the occupied Shab'a Farms.
	0700	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), an Israel enemy patrol comprising 15 individuals in military clothing arrived and conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and 10 patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory. At 0800 hours, nine trucks loaded with basecourse material arrived and dumped their loads at the site. At 0810 hours, an excavator was brought in and used to level the basecourse material all along the dirt road. At 0900, four workers in civilian clothing arrived and laid pipes in the concrete manholes. They left in the direction of occupied territory at 1500 hours, closing the gate behind them.
	1230	As the Chinese contingent of UNIFIL was detonating anti-personnel mines outside the town of Labbunah, between points B6 and B7, a fire broke out over a 50 <i>dunum</i> area of woodland grass and pines, causing 27 landmines and several bullets that had been left behind by the Israeli enemy to explode.

	1510	Opposite the town of Kafr Kila, near point B82, an Israeli enemy civilian bus approached from occupied Palestinian territory. Some 30 individuals in civilian clothing disembarked, scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1600 hours.
18 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 10 in Duhayrah, 4 in Bustan, 37 in Yarun, 3 in Mays al-Jabal, 12 in Amra, 21 in Arab al-Luwayzah and 9 in Hula.
	1845	As the civilian Muhammad al-Shartuni and his brother Hasan and their children were working on the land behind their house, outside the town of Mays al-Jabal, near point B63(1), an Israeli enemy patrol comprising a Defender vehicle and a Humvee vehicle stopped on the opposite side, in occupied Palestinian territory, and took up a position behind an earthen berm. A patrol member fired three shots into the air towards Lebanese territory and above the aforementioned persons, in order to intimidate them and drive them away. No one was harmed in the incident. They patrol left in the direction of occupied territory at 1910 hours.
20 June	0700	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), an Israel enemy patrol comprising 16 individuals in military clothing arrived and conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and 10 patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory. At 0800 hours, an excavator and a truck loaded with basecourse material arrived, and the truck proceeded to dump its load. This procedure was repeated six times. The excavator was then used to level the basecourse material all along the dirt road. At 0900, four workers in civilian clothing arrived and laid pipes in the concrete manholes. They left in the direction of occupied territory at 1600 hours, closing the gate behind them.
	0900	An Israeli enemy patrol consisting of two Humvee vehicles, a bulldozer and a trench excavator arrived from the occupied Shab'a Farms, in the locality of Birkat al-Naqqar. The bulldozer was used to level and clean the dirt road leading to Tallat al-Saddanah. Then, the excavator was used to dig a trench approximately 80 m long by the side of the road, and concrete blocks were placed in middle of the road, near the Birkat al-Naqqar gate. Meanwhile, 15 soldiers and military vehicles deployed in the area and took up combat positions. Work ended at 1600 hours, but the construction vehicles remained on the road leading to Tallat al-Saddanah. They patrol left in the direction of occupied territory at 1610 hours.
	2135	Explosions of unknown origin were heard inside the occupied Shab'a Farms.
21 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 13 in Duhayrah, 4 in Bustan and 5 in Amra.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
	0700	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), an Israel enemy patrol comprising 16 individuals in military clothing arrived and conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and 10 patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0800	An Israeli enemy patrol consisting of two Humvee vehicles and two fuel tankers arrived from the occupied Shab'a Farms, in the locality of Birkat al-Naqqar. The enemy used a bulldozer and a trench excavator (which had been left at the site) to continue cleaning and levelling the dirt road leading to Tallat al-Saddanah. Then, the excavator was used to dig a trench approximately 400 m long and 1 m deep by the side of the road. Meanwhile, 12 soldiers and military vehicles deployed in the area and took up combat positions. Work ended at 1630 hours, but the construction vehicles remained on the road leading to Tallat al-Saddanah. The patrol left and headed towards occupied territory.
	0830	In Lebanese territory, near point TP36(2), as a water tanker belonging to the police force of Udaysah municipality was watering trees in that area, an Israeli enemy soldier on the occupied side fired into the air towards Lebanese territory and over the head of a municipal worker, without injuring anyone. At 0835 hours, as a Lebanese Army patrol was inspecting the scene of the incident, the Israeli enemy fired into the air towards Lebanese territory, without injuring anyone.
	1945	Outside the town of Mays al-Jabal, opposite point B63, as the civilian Muhammad al-Shartuni and his wife were strolling down the dirt road next to his house, three Israeli enemy soldiers spread out along the earthen berm at the enemy's position and one of the soldiers fired into the air towards Lebanese territory, in order to intimidate the couple. No one was hurt in the incident.
22 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 2 in Bustan, 9 in Duhayrah, 19 in Yarun, 19 in Amra, 19 in Mays al-Jabal and 18 in Arab al-Luwayzah.
	0700	In occupied Lebanese territory, on the outskirts of the town of Udaysah, near point TP36(2), an Israel enemy patrol comprising 16 individuals in military clothing arrived and conducted a foot patrol, proceeding as far as the area near point TP37. They opened a metal gate in the technical fence and 10 patrol members took up positions inside the emplacement situated at the site, while the rest took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0800	In the occupied Shab'a Farms, in the locality of Birkat al-Naqqar, the enemy used a bulldozer and three trench excavators to continue levelling the dirt road leading to Tallat al-Saddanah. Then, the excavator was used to dig a trench approximately 250 m long and 1 m deep. Meanwhile, 15 soldiers and military vehicles deployed in the area and took up combat positions. Work ended at 1630 hours, but the construction vehicles remained on the road leading to Tallat al-Saddanah. The patrol left and headed towards the Ruwaysat al-Alam position, in occupied territory.

23 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 14 in Mays al-Jabal, 4 in Bustan, 21 in Duhayrah, 12 in Yarun, 16 in Amra and 2 in Hula.
