**Land violations committed in December 2019**

2 December	0630	Inside Lebanese territory, outside the town of Yarun, a team from the Chinese contingent of the United Nations Interim Force in Lebanon (UNIFIL) detonated 10 landmines that had been left behind by the Israeli enemy.
	0730	Inside occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a Hummer vehicle towards Lebanese territory. The enemy soldiers left in the direction of occupied territory at 0800 hours.
	0940	Inside occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 1045 hours.
3 December	0730	Inside occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy's Jabal al-Tayyarah position, enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0900 hours.
	0930	Inside occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy's Jabal al-Tayyarah position, enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 1130 hours.
4 December	0730	Inside occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy's Jabal al-Tayyarah position, enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0855 hours.
	1110– 1125	Inside the occupied Shab'a Farms, on the perimeter of the Fashkul position, the Israeli enemy fired light and medium weapons as enemy warplanes flew overhead.
	1129	Inside occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a Hummer vehicle towards Lebanese territory. The enemy soldiers left in the direction of occupied territory at 1515 hours.
5 December	0700	Inside Lebanese territory, outside the town of Yarun, a team from the UNIFIL Chinese contingent detonated 10 landmines that had been left behind by the Israeli enemy.
	0740	Inside occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a Hummer vehicle towards Lebanese territory. The enemy soldiers left in the direction of occupied territory at 0950 hours.

	0800	Inside occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 1315 hours.
	0800	Inside occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy's Jabal al-Tayyarah position, enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0940 hours.
	0930	Inside occupied Lebanese territory, in Ra's al-Naqurah district, enemy personnel, nine in civilian clothing and one in a military uniform, conducted a patrol behind the steel separation fence, starting to the west of point M2 and proceeding west for some 150 m. At 0930 hours, they headed back to point M2 before leaving in the direction of occupied territory.
6 December	0740	Inside occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy's Jabal al-Tayyarah position, enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0900 hours.
	0930	Inside occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy's Jabal al-Tayyarah position, enemy soldiers pointed the cannon of two Merkava tanks towards the town of Udaysah and Sahl al-Khiyam. The tanks left in the direction of occupied territory at 1055 hours.
7 December	1320	In occupied Palestinian territory, opposite the town of Ayta al-Sha'b, near the Israeli enemy's Khallat Wardah position, two individuals in civilian clothing photographed the Hadab position and the Lebanese side. They left in the direction of occupied territory at 1340 hours.
10 December	0750	Inside occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy's Jabal al-Tayyarah position, enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0850 hours.
	1000	A Hummer vehicle and a construction vehicle stopped in occupied Palestinian territory, opposite the town of Udaysah, near point TP37. Four individuals stepped out of the vehicles and carried out maintenance work on the steel gate in the technical fence. One of the individuals pointed the machine gun mounted on the Hummer vehicle towards Lebanese territory. Those individuals left in the direction of occupied territory at 1020 hours.
	1040	Inside occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a Hummer vehicle towards Lebanese territory. The enemy soldiers left in the direction of occupied territory at 1123 hours.
11 December	0800	Inside occupied Palestinian territory, opposite the town of Udaysah, near point TP36(2), Israeli enemy soldiers pointed a machine gun mounted on a Hummer vehicle towards Lebanese territory. The enemy soldiers left in the direction of occupied territory at 0835 hours.

	1420	Inside occupied Palestinian territory, opposite the town of Rumaysh, near point B37, two Israeli enemy soldiers pointed their weapons at an Observer Group Lebanon patrol that was on the other side. The soldiers left in the direction of occupied territory at 1428 hours.
12 December	0750	Inside occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy's Jabal al-Tayyarah position, enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0820 hours.
14 December	1900–1912	From inside the occupied town of Ghajar, the Israeli enemy fired six flare shells over the outskirts of the town.
16 December	1010	A patrol comprising two civilian buses stopped inside occupied Palestinian territory at the Israeli enemy's Jabal al-Tayyarah position, opposite the town of Kafr Kila. Some 50 individuals in civilian clothing stepped out, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1050 hours.
	1340	A patrol comprising a Humvee vehicle and a Defender vehicle stopped inside occupied Palestinian territory, opposite Sahl al-Khiyam, near Barad al-Tuffah. Three individuals in military clothing stepped out and conducted maintenance work on the gate in the technical fence. As they worked, they pointed the machine gun mounted on the Humvee towards Lebanese territory. They left in the direction of occupied territory at 1410 hours.
18 December	0750	Inside occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy's Jabal al-Tayyarah position, enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0900 hours.
	0800	A civilian bus belonging to the Israeli enemy stopped inside occupied Palestinian territory, opposite the town of Udaysah, near point TP36(1). Some 30 individuals in civilian clothing stepped out, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 0920 hours.
	0800	An Israeli enemy patrol consisting of a Defender vehicle, a pickup truck and a civilian van arrived from inside occupied Palestinian territory and stopped opposite Mays al-Jabal. Eleven individuals in military clothing and a dog stepped out of the vehicles and crossed the technical fence through the gate that is opposite point B64. They searched the area, proceeding as far as point B65 without violating the Blue Line. As they were searching, the cannon of a Merkava tank that was at the Ruwaysah position was pointed at the Lebanese Army personnel. The enemy personnel left in the direction of occupied territory at 0855 hours and then the tank left at 0930 hours.
	1320	Inside occupied Palestinian territory, opposite Aytarun, Israeli enemy soldiers pointed a 12.7 mm machine gun mounted on a Hummer vehicle towards a Lebanese Army patrol. The Hummer vehicle left in the direction of occupied territory at 1335 hours.

19 December	0751	Two Hummer vehicles stopped in occupied Palestinian territory, opposite the town of Udaysah, near point TP37. Two individuals in military clothing stepped out of the vehicles and inspected the steel gate in the technical fence. One of the individuals pointed the machine gun mounted on the Hummer vehicle towards Lebanese territory. The individuals left in the direction of occupied territory at 0840 hours.
	1100	A civilian bus belonging to the Israeli enemy stopped inside occupied Palestinian territory, opposite the town of Udaysah, near point TP36(1). Some 50 individuals in civilian clothing stepped out, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1150 hours.
22 December	0940	Inside occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a Hummer vehicle towards Lebanese territory. The enemy soldiers left in the direction of occupied territory at 1645 hours.
23 December	0800	Inside occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a Hummer vehicle towards Lebanese territory.
	0930	A civilian bus belonging to the Israeli enemy stopped inside occupied Palestinian territory, opposite the town of Udaysah, near point TP36(1). Some 150 individuals in civilian clothing stepped out, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1150 hours.
	1550	A military delegation contingent consisting of 15 soldiers stopped inside occupied Palestinian territory at the Israeli enemy's Shaykh Abbas position, opposite the town of Hula. They proceeded to reconnoitre the area and photographed the Lebanese side. They left in the direction of occupied territory at 1620 hours.
25 December	1920–1940	From inside the occupied town of Ghajar, the Israeli enemy fired six flare shells over the northern outskirts of the town.
30 December	0800	Inside occupied Palestinian territory, opposite the towns of Aytarun and Blida, between points BP26 and B58(1), Israeli enemy soldiers pointed a machine gun mounted on a Hummer vehicle towards a Lebanese Army patrol and Lebanese territory.
31 December	0830	A civilian bus belonging to the Israeli enemy stopped inside occupied Palestinian territory, opposite the town of Kafr Kila, near the Israeli enemy's Jabal al-Tayyarah position. Some 25 individuals in civilian clothing stepped out, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 0915 hours.

8 December	1315	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for five minutes, proceeding on its way for some 70 m. Its crew sounded warning sirens and broadcast in Hebrew over loudspeakers as follows: <ul style="list-style-type: none"> <li>• At 1315 hours for 3 minutes.</li> <li>• At 1320 hours for 5 minutes.</li> <li>• At 1347 hours for 3 minutes.</li> </ul>
	1315	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for five minutes, proceeding on its way for some 335 m. The launch then left in the direction of occupied Palestinian territorial waters.
10 December	1345	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) as follows: <ul style="list-style-type: none"> <li>• At 1345 hours, for 5 minutes and a distance of approximately 185 m. The launch then left in the direction of occupied Palestinian territorial waters.</li> <li>• At 1357 hours, for eight minutes and a distance of approximately 390 m. The launch then left in the direction of occupied Palestinian territorial waters.</li> </ul>

	1030	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over Kafr Kila. It circled over the Western Bekaa and the South before leaving at 1250 hours over Kafr Kila.
	1100	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over Kafr Kila. It circled over the South before leaving at 1350 hours over Rumaysh.
	1115	Two Israeli enemy warplanes violated Lebanese airspace, entering over Alma al-Sha'b. They headed east as far as Jubayl, before leaving at 1125 hours over the sea west of Jubayl and heading north.
	1150	Two Israeli enemy warplanes violated Lebanese airspace, entering over the sea west of Naqurah and heading north as far as Shikka. They circled over the South before leaving at 1210 hours over Rumaysh.
