INTRODUCTION

1. La Commission des Nations Unies pour le droit commercial international (CNUDCI), soucieuse d'aider à faire face à la nécessité de former un plus grand nombre d'experts locaux en matière de droit international, notamment dans les pays en voie de développement, a décidé, à sa deuxième session, tenue à Genève en mars 1969, de prier le Secrétaire général :

"de prendre les mesures nécessaires pour faire ajouter les noms de spécialistes du droit commercial international, ainsi que des renseignements pertinents à leur sujet, dans un Supplément au registre d'experts et de spécialistes du droit international, conformément à ce qui est indiqué au paragraphe 36 ii) a) du rapport du Secrétaire général (A/CN.9/27). 1/"

2. Pour donner suite à cette décision, le Secrétaire général a, dans une note verbale datée du 25 février 1970, prié les gouvernements de communiquer les noms, accompagnés de tous renseignements utiles, de ceux de leurs ressortissants qui seraient jugés qualifiés, de par leur expérience et la réputation qu'ils ont acquise dans les différentes branches du droit commercial international, pour figurer dans le supplément au registre mentionné ci-dessus. Le Secrétaire général a précisé que les noms communiqués devaient être ceux d'experts qui se seraient déclarés prêts à mettre leurs services à la disposition de pays en voie de développement, afin que le supplément puisse être utilement consulté par ces pays en cas de besoin.

3. En réponse à la note du Secrétaire général, 23 gouvernements ont communiqué des noms d'experts et de spécialistes, accompagnés de renseignements les concernant. Ces noms et renseignements figurent dans le présent supplément. Tous les renseignements sont publiés dans la langue dans laquelle ils ont été

communiqués, sauf dans le cas du russe; ils ont été édités et, dans la mesure du possible, classés sous les rubriques suivantes : nom, fonctions actuelles, études et qualifications professionnelles, expérience professionnelle, domaines de spécialisation, connaissances linguistiques et principales publications (compte tenu des exigences de concision, seuls les titres des ouvrages publiés ont été indiqués sous cette dernière rubrique).

4. Le registre fera de temps à autre l'objet d'une mise à jour.
