### Lettre datée du 27 mars 2007, adressée au Président du Conseil de sécurité par le Secrétaire général

J'ai l'honneur de me référer à mes lettres datées du 10 juillet 2006 (S/2006/510) et du 8 décembre 2006 (S/2007/46) concernant l'examen des lettres de crédit émises dans le cadre du programme « pétrole contre nourriture ».

Comme suite à ces lettres, vous aviez demandé que le Contrôleur de l'Organisation des Nations Unies consulte les autorités iraquiennees compétentes en vue de régler les questions en suspens.

Les autorités compétentes du Gouvernement iraquieren se sont entretenues avec le Contrôleur à Amman le 6 mars 2007. Vous trouverez ci-joint une note récapitulant les principaux résultats de cette rencontre et la marche à suivre recommandée.

### **Note du Secrétaire général concernant les arrangements pour la liquidation des opérations relatives aux lettres de crédit émises sur le compte Iraq ouvert par l'Organisation des Nations Unies en application de la résolution 1483 (2003) du Conseil de sécurité**

1. Comme indiqué à l'annexe I, il existe 55 lettres de crédit d'une valeur totale d'environ 226,9 millions de dollars que le Gouvernement iraquien et le Secrétariat de l'Organisation des Nations Unies ont décidé d'annuler. En outre, les ministères compétents ont demandé au Secrétariat d'annuler 59 lettres de crédit d'une valeur totale de 75,1 millions de dollars. Un examen postérieur a indiqué que ces dernières étaient accompagnées de déclarations de livraison. Elles ne seront en conséquence annulées que lorsque l'on aura vérifié qu'il n'existe pas de déclaration en souffrance.

2. Les ministères concernés ont également demandé la prorogation de la validité de 85 lettres de crédit jusqu'à la fin de 2007. Le Gouvernement iraquien a été prié de communiquer à l'ONU dans les meilleurs délais toutes les demandes de modification par l'intermédiaire de la Banque centrale iraquienne. Il a été souligné à cet égard que le Secrétariat ne serait pas à même d'accorder de prorogation qui se traduirait par une livraison au-delà du 31 décembre 2007.

3. Il existe en outre actuellement 184 lettres de crédit, d'une valeur d'environ 182 millions de dollars, qui sont arrivées à échéance en 2004, 2005 et 2006 (voir annexe VII) et pour lesquelles des fournisseurs ont présenté des déclarations de livraison. Comme indiqué dans la lettre datée du 2 février 2007 que le Contrôleur a adressée au Représentant permanent de l'Iraq auprès de l'Organisation des Nations Unies, la plupart de ces fournisseurs ont présenté leurs pièces à la banque qui détient le compte Iraq ouvert par l'ONU et cette banque n'a pas pu les régler rapidement conformément aux conditions définies par les lettres de crédit faute des pièces justificatives attestant l'arrivée en Iraq des marchandises concernées. Comme convenu à la réunion d'Amman, le Gouvernement iraquien a été prié de communiquer ces pièces justificatives dans les meilleurs délais.

4. L'attention du Conseil de sécurité est également appelée sur les allégations selon lesquelles des pièces justificatives seraient retenues abusivement en Iraq, dont il est question dans la lettre du Secrétaire général en date du 8 décembre 2006 (S/2007/46) et dans la lettre correspondante du Président du Conseil de sécurité en date du 29 janvier 2007 (S/2007/47). À ce jour, le Secrétariat n'a reçu aucune indication supplémentaire concernant ces allégations. La situation pourrait gravement compromettre la possibilité de mettre un terme au programme en temps utile.

### **Mesures que le Conseil de sécurité pourrait prendre**

5. Le Conseil pourrait décider d'appuyer la proposition de prorogation de la validité des lettres de crédit figurant au paragraphe 2 ci-dessus. Il souhaitera peut-être, en outre, affirmer résolument qu'il faut régler d'urgence le problème chronique lié à la lenteur avec laquelle les pièces justificatives sont communiquées ou à leur non-communication. Enfin, il voudra peut-être engager le Gouvernement iraquien à

régler définitivement et dans les meilleurs délais la question des allégations selon lesquelles des pièces justificatives seraient retenues abusivement en Iraq afin que tous les engagements soient honorés.

**Rencontre entre des représentants du Secrétariat de l'Organisation des Nations Unies et des ministères iraquien au sujet du programme « pétrole contre nourriture »**

**Amman, 6 mars 2007**

1. Une rencontre a eu lieu le mardi 6 mars 2007 à Amman entre des représentants du Gouvernement iraquien et du Secrétariat de l'Organisation des Nations Unies, en vue d'examiner les arrangements visant à mettre un terme au programme « pétrole contre nourriture », conformément aux dispositions de la résolution 1483 (2003) du Conseil de sécurité.

2. Les participants à cette rencontre ont entendu un exposé concernant l'état récapitulatif du traitement des lettres de crédit en souffrance au 31 décembre 2006. Il a été noté qu'il restait 310 lettres de crédit, d'une valeur de plus de 915 millions de dollars. Il s'agit du reliquat des 20 435 lettres de crédit émises par BNP Paribas pour le programme « pétrole contre nourriture », dont 184, d'une valeur de 182 millions de dollars, étaient accompagnées de déclarations de livraison mais par des pièces justificatives nécessaires. Le représentant du Secrétariat a fait observer que certains fournisseurs continuaient de présenter des réclamations concernant la lenteur avec laquelle les pièces justificatives étaient examinées, ce qui inquiétait également le Conseil de sécurité.

3. Il a également été constaté que de nombreuses lettres de crédit étaient arrivées à échéance et pourraient en principe être annulées. Le Secrétariat estimait qu'elles étaient au nombre de 93 et que leur valeur totale s'élevait à 492 millions de dollars.

4. Le Représentant du Gouvernement iraquien a indiqué qu'au total, le nombre de lettres de crédit arrivées à échéance qui pourraient être annulées pourrait être supérieur à 93. Quoi qu'il en soit, il faudrait procéder au rapprochement des registres des ministères et du Secrétariat afin de parvenir à des arrangements visant à annuler les lettres de crédit en question et à reverser les fonds de garantie, actuellement détenus par BNP Paribas, au Fonds de développement pour l'Iraq.

5. Les représentants du Gouvernement iraquien ont indiqué que compte tenu de la situation sur le terrain en Iraq, il faudrait proroger la validité de certaines des lettres de crédit arrivées à échéance. Des demandes seraient donc présentées pour reporter l'échéance de ces lettres à une date ultérieure en 2007, voire, dans certains cas, au-delà. Le représentant du Secrétariat a fait observer que des demandes de prorogation avaient déjà été présentées à deux reprises au Conseil de sécurité, qui les avait approuvées en 2005 et 2006. Compte tenu de ce qui précède et de la nécessité de mettre un terme au programme en application de la résolution pertinente du Conseil de sécurité, le Secrétariat ne serait pas à même d'accorder des prorogations au-delà de 2007. Il estimait que si les contrats n'étaient pas exécutés d'ici à la fin de 2007, il faudrait reverser le reliquat au Fonds de développement pour l'Iraq et il incomberait au Gouvernement iraquien d'administrer ce qui restait des contrats en souffrance.

6. Le représentant de l'Iraq a soulevé la question du remboursement des pénalités imposées à certains fournisseurs qui n'avaient pas exécuté leurs contrats selon les termes convenus. Le représentant du Secrétariat a fait observer que la politique établie ne prévoyait pas le remboursement des pénalités aux fournisseurs. Il a toutefois indiqué que, dans certains cas, l'inexécution des contrats était due à la force majeure et que la situation serait examinée plus avant à New York, avec le concours du Bureau des affaires juridiques.

### **Conclusions**

7. Les participants à la réunion ont pris les décisions ci-après :

a) Une liste des lettres de crédit arrivées à échéance devait être dressée par le Secrétariat en concertation avec le Gouvernement iraquien; les contrats et lettres de crédit correspondants seraient annulés et les fonds reversés au Fonds de développement pour l'Iraq en mars 2007;

b) Le Gouvernement iraquien devait accélérer le traitement des pièces justificatives afin que les fournisseurs soient payés dans les meilleurs délais. Il convenait de s'intéresser en particulier aux lettres de crédit accompagnées de déclarations en souffrance, d'une valeur de 184 millions, énumérées dans le tableau 1 a) figurant dans la lettre du Contrôleur en date du 2 février 2007. Les deux parties ont reconnu qu'il fallait redoubler d'efforts pour raccourcir la période de notification;

c) Le Gouvernement iraquien fournirait une liste des contrats dont il souhaitait demander la prorogation au Conseil de sécurité. Le Secrétariat s'est engagé à communiquer ces informations au Conseil mais ne ferait aucune recommandation concernant cette proposition; il a toutefois indiqué que si ces contrats n'étaient pas exécutés d'ici au 31 décembre 2007, il faudrait conclure des arrangements visant à transférer les fonds correspondants au Fonds de développement pour l'Iraq, ainsi que la responsabilité de l'administration et du règlement des contrats qui reviendrait au Gouvernement iraquien;

d) Il a été convenu que, dans un petit nombre de cas d'inexécution des contrats due à la force majeure, on s'en remettrait au Bureau des affaires juridiques;

e) Le Secrétariat s'est engagé à porter ces questions à l'attention du Conseil de sécurité en mars 2007. Le Gouvernement iraquien a signalé qu'il se mettrait également en rapport avec le Conseil de sécurité à propos des décisions ci-dessus.
