**Revitalization of the work of the General Assembly****Options for the rescheduling of the Main Committees of the General Assembly****Note by the Secretariat****I. Introduction and background**

1. In its resolution 58/126, the General Assembly indicated that the work of its Main Committees might benefit if they were scheduled over two substantive periods during the session. The Assembly emphasized that such rescheduling should not lead to additional costs, additional or longer meetings, or staggered work schedules of the Main Committees. With a view to enabling the Assembly to consider changes in this regard, with effect from its sixtieth session, the Assembly requested the Secretary-General to present, by 1 February 2004, various options for its consideration, taking into account the requirements of the relevant intergovernmental bodies and the different locations of their meetings and the budget cycle. The present report has been prepared in compliance with that request.

2. It should be noted that the calendar of conferences and meetings of the hundreds of United Nations and related bodies at all the duty stations has evolved and significantly expanded during the past five decades. As new mandates were adopted, new bodies created and sessional dates and locations decided upon, so were substantive, technical and conference-servicing capacities created to accommodate those meetings. As the system grew more complex, covering many emerging substantive issues of international concern, the calendar also became more complex, with parent organs establishing subsidiary bodies and setting up their reporting lines to the Charter organs. The servicing mechanism kept pace with the growth of the system and made the functioning of the intergovernmental machinery possible throughout the years.

3. In the current system, the largest and most intensive culmination of meeting activities occurs during the main part of the General Assembly session, from mid-September to mid-December. In the context of discussions on the reform and revitalization of the Assembly, Member States and regional groups have expressed growing support for modifying the programme of work of the Assembly, arguing

that the compression of work into a three-month period, however desirable it might have proven to be in the past, has long since become both counter-intuitive and counterproductive. That was found to be particularly true for countries with smaller delegations. Thus, the Secretariat was requested to provide various alternative scenarios for the consideration of Member States.

## **II. Options**

4. In compliance with that request, the Secretariat has prepared two versions of a mock calendar of conferences and meetings for 2005 (see annexes I and II). In this tentative and indicative draft, when reconfiguring the meeting schedule of the Main Committees, every effort was made to do so in a way that disturbs to the least extent possible the working relationships and reporting obligations of subsidiary and related organs. The underpinnings of the prospective programme, as envisaged, are that the plenary will meet as required in the course of the year to take up items emerging from the Main Committees, along with other items and issues under its domain. The General Debate would remain in its usual time frame, commencing the Tuesday after the opening of the session of the General Assembly.

5. It is equally important to note that the mock calendars do not envisage additional meetings (the only exception being the International Law Weeks in option I (see annex I, item 205)) or additional costs for meeting servicing. No meeting venue was changed in either version.

6. When preparing the mock calendars, in addition to the aforementioned main considerations, the focus was on the physical possibility of providing meetings and documentation services to the Main Committees and other major organs and their subsidiary machinery.

7. In the process of preparing the options, limited consultations took place within the substantive and servicing departments and at the various duty stations. An early version of option I was circulated to Member States late in 2003 and the valuable feedback received was taken into account when preparing the updated version of option I as well as option II. Owing to time constraints, the finer details of the reporting obligations and timing requirements will have to be considered at a later stage. In addition, at the various duty stations, further consultations will be necessary with the agencies and treaty bodies that are serviced by the relevant duty stations.

8. Intensive dialogue within the Secretariat and with the Member States will be required to make either of these options feasible. Bearing this in mind, the options and the reconfigured meetings schedules of the Main Committees and their related organs should be considered as indicative, not as definite. Some bodies have been included with specific dates in the options, although in the 2005 calendar, as adopted by the General Assembly in its resolution 58/250, no dates had been fixed. It was necessary to do so in order to verify if the required conference services workload could be absorbed in the tentatively indicated time frames. To facilitate easy comparison the dates from the adopted calendar are included with the new dates in the mock calendars. If there is no change between adopted and mock dates, it is indicated by "Same".

9. The following features of the mock Calendars should be highlighted:

- In option I, the First, Fourth and Sixth Committees would meet in the January-May period; the Second and Third Committees would meet in the September-December period. The substantive session of the Economic and Social Council and its subsidiary bodies would be left mostly unchanged. There will, however, be changes in some of the bodies in the disarmament and legal fields
- In option II, the Second and Third Committees would meet in the February-May period, the First, Fourth and Sixth Committees would meet in the October-December period. With this option, most of the subsidiary bodies of the Economic and Social Council, as well as the Council itself, would need to be changed. The Council would have its session in July, as in the adopted calendar, with the exception of the review of its subsidiaries, which would need to take place in January to make it possible for the Second and Third Committees to consider their relevant decisions in February-March. (It should be noted that while another option to make this review possible would be to schedule the full substantive session of the Council in November-December, it was determined that this option would, in effect, recreate a full meeting calendar for the latter part of the year, thus contradicting the primary purpose of this exercise)
- In both options, the organs involved in the regular budget review (Fifth Committee, the Advisory Committee on Administrative and Budgetary Questions and the Committee for Programme and Coordination) were kept close to their “current” dates
- In both options, the First and Fourth Committees are scheduled as they are currently, that is, to alternate their meetings mornings and afternoons. Alternatively, they could meet one after the other, with their programmes of work condensed into shorter, more intensive sessions, with meetings both mornings and afternoons, or the meetings could be spread out, with only one meeting a day over a longer period of time.

### III. Other considerations

10. It should be noted that certain elements of the two options would conflict with standing mandates. Should either option, or variation thereon, be chosen, such mandates would need to be reformulated. For example, in both options I and II, resolution 40/243 would need to be amended concerning the 1 September reporting deadline for General Assembly subsidiaries and a decision would have to be taken pertaining to paragraph I.7 of that resolution regarding simultaneous meetings of subsidiary bodies of the General Assembly and the Assembly itself.
11. Should option I be selected, the Conference on Disarmament may need to revise its rules of procedure to reduce or time differently the first part of its session prior to the meetings of the First Committee.
12. Should option II be chosen, the rules of procedure of the Economic and Social Council would need to be amended to reflect the new timing of the session, as would Council resolution 1982/50, by which the Council requires that all subsidiaries end their session at least eight weeks before the Council’s substantive session.
13. However, such changes could easily be accomplished by an omnibus resolution of the General Assembly revising the provisions of all relevant resolutions.

## **IV. Conclusions**

14. As indicated in the annexes to the present report, it is feasible, from a conference servicing point of view, to stagger in a number of ways the meetings of the Main Committees of the General Assembly and other intergovernmental and subsidiary bodies over two substantive periods. It is also clear that regardless of which option is chosen, there are numerous implications for the calendar of conferences.

15. Should it be the intention of the General Assembly to achieve the objective of staggering the meetings of its Main Committees with the least possible disruption in the schedule of other meetings of the United Nations, then option I appears to be more conducive. It should be noted that the largest number of subsidiary bodies are in the economic and social field and, in the scenario envisaged in option I, the current schedule of those bodies would be disrupted only slightly. As indicated above, more detailed consultations would be necessary, following the consultations of the General Committee and the General Assembly, to refine further any proposed new schedule.
