### Appointments to fill vacancies in subsidiary organs and other appointments

## Appointment of members of the Joint Inspection Unit

### Note by the President of the General Assembly

1. As indicated in paragraph 3 of the note by the Secretary-General (A/61/109) of 12 April 2006, the General Assembly is required, during its current session, to appoint five members of the Joint Inspection Unit to fill the vacancies that will arise from the expiration of the terms of office of Mr. Even Francisco Fontaine Ortiz, Mr. Tang Guangang, Mr. Victor Vislykh, Ms. Deborah Wynes and Mr. Muhammad Yussuf on 31 December 2007.

2. In accordance with the procedures described in article 3, paragraph 1, of the statute of the Joint Inspection Unit, at the 55th plenary meeting of the General Assembly on 16 November 2006, the President of the General Assembly, having consulted Member States and having drawn up a list of countries from among the Group of African States, the Group of Asian States, the Group of Eastern European States, the Group of Latin American and Caribbean States and the Group of Western European and other States, requested China, Cuba, Egypt, the Russian Federation and the United States of America to propose candidates (see annexes I-V) to serve for a period of five years beginning 1 January 2008.

3. The candidates, in accordance with paragraph 7 of General Assembly resolution 59/267 of 23 December 2004, should have experience in at least one of the following fields: oversight, audit, inspection, investigation, evaluation, finance, project evaluation, programme evaluation, human resources management, management, public administration, monitoring and/or programme performance, in addition to knowledge of the United Nations system and its role in international relations.

4. The President of the General Assembly has held the consultations described in article 3, paragraph 2, of the statute of the Joint Inspection Unit, including consultations with the President of the Economic and Social Council and with the Secretary-General, in his capacity as Chairman of the United Nations System Chief Executives Board for Coordination. The replies received from the President of the Economic and Social Council and from the Secretary-General to identical letters



addressed to them on 26 and 29 January 2007, respectively, by the President of the Assembly are attached (see annexes VI and VII).

5. Having completed the required consultations, the President of the General Assembly has the honour to submit to the Assembly the following candidates for appointment as members of the Joint Inspection Unit for a five-year term beginning on 1 January 2008 and expiring on 31 December 2012:

Mr. Even Francisco Fontaine Ortiz (Cuba)

Mr. Mohamed Mounir-Zahran (Egypt)

Ms. Deborah Wynes (United States of America)

### **Letter dated 28 November 2006 from the Permanent Representative of Egypt to the United Nations addressed to the President of the General Assembly**

I wish to refer to the elections held on 16 November 2006 during the sixty-first session of the General Assembly to elect five Member States from which the President of the General Assembly would receive nominations for the appointment of five inspectors to the Joint Inspection Unit for a term of five years beginning on 1 January 2008.

As you are fully aware, Egypt was among those five countries elected to fill the only vacant seat for Africa in the Joint Inspection Unit beginning on the aforementioned date. In this context, I am pleased to inform you of the decision by the Government of Egypt to submit the nomination of Mr. Mohamed Mounir-Zahran for appointment as an inspector in the Joint Inspection Unit for the term 2008-2013. The curriculum vitae of the Egyptian nominee is enclosed herewith (see enclosure).

In light of the particular qualifications required to support the nomination of Mr. Mounir-Zahran, I wish to highlight the following salient features of his background and expertise.

Mr. Mounir-Zahran has a career as a lawyer in Egypt. During his studies at the University of Paris, he submitted a “Mémoire sur l’administration locale en Égypte” and a Ph.D. thesis on “L’Association Internationale de Développement et sa contribution au développement économique”. Furthermore, as an Egyptian Foreign Service officer, he was tasked with the management of the Economic and International Organizations Departments in the Ministry of Foreign Affairs in Cairo. He was assigned to serve as a member of the Permanent Mission of Egypt to the United Nations in New York and subsequently as Permanent Representative to the United Nations Office at Geneva and to the United Nations specialized agencies, the General Agreement on Tariffs and Trade (GATT) and the World Trade Organization. His experience in the work and activities of the United Nations includes participation in the meetings of the Second Committee of the General Assembly, the Economic and Social Council, the United Nations Conference on Trade and Development and other United Nations functional and subsidiary bodies. He was elected President of the Committee of Participants of the Global System of Trade Preferences, Chairman of the GATT Committee on Trade and Development and the GATT Council of Representatives and Contracting Parties. He served as Vice-President of the United Nations Conference on Trade and Development and the Trade and Development Board. He was also Chairman of the Government Group of the International Labour Organization, the International Labour Conference and the Coordination Committee of the World Intellectual Property Organization. In addition, Mr. Mounir-Zahran participated in several annual meetings of the International Monetary Fund and the World Bank, including the meetings of the Group of 24. He also served as a member of the Advisory Committee on Administrative and Budgetary Questions from 2003-2005.

The Government of Egypt believes in the relevance and significance of the work of the Joint Inspection Unit and its role in ensuring the efficiency, transparency and sound governance of the United Nations. It is out of this strong

conviction that the Government of Egypt seeks the appointment of Mr. Mounir-Zahran to the Joint Inspection Unit, particularly at a time when the United Nations is undergoing major reform and renewal efforts aimed at modernizing its operations and activities and at maintaining its relevance and centrality in meeting the requirements of contemporary multilateralism.

While working in the Department's Central Budget Office, she was responsible for the Department's congressional authorization process and worked on the formulation and justification of the Department's overall budget request to the United States Congress.

In 1978, she joined the Bureau of International Organization Affairs and worked on developing and implementing United States policies relating to budgetary, administrative and management issues of the United Nations and over 60 other international organizations.

In July 1998, she was named Director of the Office of United Nations System Administration. In that capacity, she managed the entirety of the United States Government's efforts for the management and administration of the United Nations, the United Nations affiliated agencies, the inter-American system, regional organizations and others. She was responsible for developing, formulating, coordinating, recommending and implementing United States policies regarding the budgetary and management reform of those institutions. She oversaw the development and presentation of budget requests to Congress to finance United States assessed and voluntary contributions to international organizations and programmes. She guided those requests through the budget process within the Department of State and the Office of Management and Budget and served as the supporting witness to the Assistant Secretary of State for International Organization Affairs at Congressional hearings. She also served as the principal briefer to Congressional staff on all budget and finance issues relating to the United Nations and other international organizations.

Mrs. Wynes served as the United States member of the Finance Committee of the International Hydrographic Organization. She was elected to and served on the Finance Committee of the International Seabed Authority in Kingston. She has served as a delegate to the United Nations General Assembly and to the Inter-American Institute for Cooperation on Agriculture. In June 2001, she served as head of the United States delegation to the United Nations Committee for Programme and Coordination meeting.

Appointed by the United Nations General Assembly as an inspector, Mrs. Wynes began her term on the Joint Inspection Unit in January 2003. In 2004 and 2005, she was elected Vice-Chairman of the Unit and in 2006, she was elected Chairperson. In late 2006, she was re-elected Chairperson for 2007.
