### Elections to fill vacancies in principal organs

#### (a) Election of five non-permanent members of the Security Council

**The President** (*spoke in Arabic*): As members will recall, the result of the tenth round of balloting, which took place at the end of this morning's plenary meeting (see A/66/PV.39), was inconclusive. The Assembly must therefore proceed to a fourth unrestricted ballot. This eleventh round of balloting is in accordance with rule 94 of the rules of procedure.

May I remind the Assembly that any Member State from among the Eastern European States may be a candidate except outgoing members, those already members of the Security Council, as well as those just elected. To make this clear, in addition to the permanent members of the Security Council, Bosnia and Herzegovina cannot be voted for in the present balloting.

Before we begin the voting process, I should like to remind members that, pursuant to rule 88 of the rules of procedure of the General Assembly, no representative shall interrupt the voting except on a point of order on the actual conduct of the voting. In addition, ballot papers will be given only to the representative seated directly behind the country's nameplate.

We shall now begin the voting process.

Ballot papers marked "B" will now be distributed. May I ask representatives to write on the ballot papers the name of the State for which they wish to vote. Ballot papers marked "B" for the Eastern European States will be declared invalid if they contain the name of more than one State.

**Mr. Žbogar** (Slovenia): We entered this race for a Security Council seat 11 years ago, and we believe that we are a good candidate and a good fit for today's Council. Our campaign was always for Slovenia and the values we represent. We were never campaigning against any other candidate.

We do not approve of the way this campaign was run, and we do not approve of the way these elections were held. However, the current result speaks for itself and the object of this body's support is obvious. I am therefore withdrawing our candidature. I want to thank all the countries that stayed with us for supporting us.

**The President:** Taking into account the statement made by the representative of Slovenia, we shall now proceed to the next unrestricted ballot, in accordance with rule 94 of the rules of procedure.

I warmly congratulate the States that have been elected members of the Security Council, and I thank the tellers for their assistance in this election.
