Seventy-second session

Organization of the seventy-second regular session of the General Assembly, adoption of the agenda and allocation of items

Second report of the General Committee

1. At its 1st meeting, on 13 September 2017, the General Committee decided to postpone its consideration of the question of the inclusion of the item entitled “Complete withdrawal of foreign military forces from the territory of the Republic of Moldova” to its next meeting ([A/72/250](#), para. 89). At its 2nd meeting, on 23 October 2017, the General Committee decided to postpone its consideration of the question of the inclusion of the item to one of its subsequent meetings.

2. At the same meeting, the General Committee considered a request submitted by the Secretary-General ([A/72/231](#)) for the inclusion in the agenda of the seventy-second session, under item 115 entitled “Appointments to fill vacancies in subsidiary organs and other appointments”, of an additional sub-item entitled:

“Confirmation of the appointment of members of the Investments Committee”.

In that connection, the General Committee decided to recommend to the General Assembly that the item:

(a) Be included in the agenda under heading I (Organizational, administrative and other matters);

(b) Be allocated to the Fifth Committee.

3. At the same meeting, the General Committee considered a request submitted by the Plurinational State of Bolivia ([A/72/232](#)) for the inclusion in the agenda of the same session of an additional item entitled:

“Observer status for the Fund for the Development of the Indigenous Peoples of Latin America and the Caribbean in the General Assembly”.

In that connection, the General Committee decided to recommend to the General Assembly that the item:

(a) Be included in the agenda under heading I (Organizational, administrative and other matters);

(b) Be allocated to the Sixth Committee.

4. At the same meeting, the General Committee considered a request submitted by Côte d'Ivoire ([A/72/233](#)) for the inclusion in the agenda of the same session of an additional item entitled:

“Cooperation between the United Nations and the Organization of Islamic Cooperation”.

In that connection, the General Committee decided to recommend to the General Assembly that the item, revised to read:

“Cooperation between the United Nations and regional and other organizations: cooperation between the United Nations and the Organization of Islamic Cooperation”

(a) Be included in the agenda under heading I (Organizational, administrative and other matters);

(b) Be considered directly in plenary meeting.

5. At the same meeting, the General Committee considered a request submitted by Mexico ([A/72/234](#)) for the inclusion in the agenda of the same session of an additional item entitled:

“Impact of exponential technological change on sustainable development and peace”.

In that connection, the General Committee decided to recommend to the General Assembly that the item:

(a) Be included in the agenda under heading I (Organizational, administrative and other matters);

(b) Be considered directly in plenary meeting.
