## Globalization and interdependence

### Report of the Second Committee\*

### Introduction

1. At its 3rd plenary meeting, on 21 September 2018, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-third session the item entitled:

“Globalization and interdependence:

“(a) Globalization and interdependence;

“(b) International migration and development”

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on the item at its 17th meeting, on 19 October. An account of the Committee’s consideration of the item is contained in the relevant summary record.<sup>1</sup> Attention is also drawn to the general debate held by the Committee at its 2nd to 6th meetings, on 8, 9 and 10 October.<sup>2</sup> An account of the Committee’s further consideration of the item is provided in the addenda to the present report.
