Addendum

1. The Secretary-General has received notification of the resignation of Zhang Wei (China) from the Committee on Contributions, effective 12 May 2020. Accordingly, the General Assembly will be required to appoint, at its current session, a person to fill the vacancy for the remaining period of the term of office of Ms. Zhang, which expires on 31 December 2020.
2. The Government of China has nominated Lin Shan to fill the vacancy arising from the resignation of Ms. Zhang.
3. In a communication dated 20 May 2020, the Secretariat was informed by the Chair of the Group of Asia-Pacific States that the candidature of Mr. Lin had been endorsed by the Group.
