Additional time is also required to enable the Advisory Committee on Administrative and Budgetary Questions and the Fifth Committee to review those implications before the draft resolution is acted upon by the General Assembly.

<sup>1</sup> The General Assembly, in its resolution [68/307](#), decided to conduct the elections of the non-permanent members of the Security Council and the members of the Economic and Social Council about six months before the elected members assume their responsibilities, beginning at the seventieth session.
