The situation in Afghanistan

Report of the Secretary-General on the situation in Afghanistan and its implications for international peace and security ([S/2019/703](#))

The agenda was adopted without objection.

The President invited the representatives of Afghanistan, Australia, Canada, Egypt, India, the Islamic Republic of Iran, Italy, Japan, Kazakhstan, Pakistan, Turkey and Uzbekistan to participate in the meeting in accordance with rule 37 of the Council's provisional rules of procedure.

The President invited the following individuals to participate in the meeting in accordance with rule 39 of the Council's provisional rules of procedure: Mr. Tadamichi Yamamoto, Special Representative of the Secretary-General and Head of the United Nations Assistance Mission in Afghanistan; and Mr. Yury Fedotov, Executive Director of the United Nations Office on Drugs and Crime.

The President invited His Excellency Silvio Gonzato, Chargé d'affaires a.i. of the Delegation of the European Union to the United Nations, to participate in the meeting in accordance with rule 39 of the Council's provisional rules of procedure.

The Council began its consideration of the item and heard briefings by Mr. Yamamoto, Mr. Fedotov (via video-teleconference from Vienna) and by His Excellency Triansyah Djani, Permanent Representative of Indonesia to the United Nations, in his capacity as the Chair of the Security Council Committee established pursuant to resolution 1988 (2011).

The Council heard a statement by the representative of Afghanistan.

Statements were made by the representatives of Germany, Indonesia, Belgium, the United States, Peru, the United Kingdom, Poland, China, Côte d'Ivoire, Kuwait, France, Equatorial Guinea, South Africa, the Dominican Republic and by the President, speaking in his capacity as the representative of the Russian Federation.

The Council heard statements by the representatives of Turkey, Italy, Kazakhstan, Canada, Japan, Pakistan, Uzbekistan, Egypt, Australia and India.

The Council heard a statement by His Excellency Silvio Gonzato, (speaking on behalf of the European Union and its 28 Member States; the candidate countries the Republic of North Macedonia, Montenegro, Serbia and Albania, the country of the Stabilization and Association Process and potential candidate Bosnia and Herzegovina, as well as Ukraine, the Republic of Moldova and Georgia, aligned themselves with the statement).
