LETTER DATED 26 JANUARY 1970 ADDRESSED TO THE PRESIDENT OF THE SECURITY COUNCIL FROM THE REPRESENTATIVES OF AFGHANISTAN, ALGERIA, BURUNDI, CAMBODIA, CEYLON, CHAD, CONGO (DEMOCRATIC REPUBLIC OF), CONGO (PEOPLE'S REPUBLIC OF), DAHOMEY, ETHIOPIA, GABON, INDIA, INDONESIA, IRAN, IRAQ, JORDAN, KUWAIT, LAOS, LEBANON, LIBERIA, LIBYA, MALAGASCAR, MALAYSIA, MALI, MAURITANIA, MAURITIUS, MOROCCO, NEPAL, NIGER, NIGERIA, PAKISTAN, RWANDA, SENEGAL, SIERRA LEONE, SINGAPORE, SOMALIA, SOUTHERN YEMEN, SUDAN, SYRIA, TOGO, TUNISIA, TURKEY, UGANDA, UNITED ARAB REPUBLIC, UNITED REPUBLIC OF TANZANIA, UPPER VOLTA, YUGOSLAVIA AND ZAMBIA

Upon instructions from our respective Governments, and with reference to paragraph 6 of Security Council resolution 269 (1969), we have the honour to request you to convene, on an urgent basis, the Security Council, in order to examine the failure of the Government of South Africa to comply with the letter and spirit of the above-mentioned resolution and in particular its paragraph 4.
