NOTE

The resolutions and decisions of the General Assembly are identified as follows:

Regular sessions

Until the thirtieth regular session, the resolutions of the General Assembly were identified by an arabic numeral followed by a roman numeral in parentheses indicating the session (for example: resolution 3363 (XXX)). When several resolutions were adopted under the same number, each of them was identified by a capital letter placed between the two numerals (for example: resolution 3367 A (XXX), resolutions 3411 A and B (XXX), resolutions 3419 A to D (XXX)). The decisions were not numbered.

Since the thirty-first session, as part of the new system adopted for symbols of General Assembly documents, resolutions and decisions have been identified by an arabic numeral, indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution 31/1, decision 31/301). When several resolutions or decisions were adopted under the same number, each of them has been identified by a capital letter placed after the two numerals (for example: resolution 31/16 A, resolutions 31/6 A and B, decisions 31/406 A to E).

Special sessions

Until the seventh special session, the resolutions of the General Assembly were identified by an arabic numeral followed, in parentheses, by the letter "S" and a roman numeral indicating the session (for example: resolution 3362 (S-VII)). The decisions were not numbered.

Since the eighth special session, resolutions and decisions have been identified by the letter "S" and an arabic numeral indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution S-8/1, decision S-8/11).

Emergency special sessions

Until the fifth emergency special session, the resolutions of the General Assembly were identified by an arabic numeral followed, in parentheses, by the letters "ES" and a roman numeral indicating the session (for example: resolution 2252 (ES-V)). The decisions were not numbered.

Since the sixth emergency special session, resolutions and decisions have been identified by the letters "ES" and an arabic numeral indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution ES-6/1, decision ES-6/11).

In each of the series described above, the numbering follows the order of adoption.

Pursuant to paragraphs 4 (a) to (d) of resolution [60/180](#), 28 States have already been elected and/or selected as members of the Organizational Committee of the Peacebuilding Commission: EGYPT, GUATEMALA, KENYA, MEXICO and NEPAL elected by the General Assembly;¹⁸ CHINA, DOMINICAN REPUBLIC, FRANCE, NIGER, RUSSIAN FEDERATION, UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND and UNITED STATES OF AMERICA selected by the Security Council;¹⁹ BRAZIL, COLOMBIA, IRAN (ISLAMIC REPUBLIC OF), IRELAND, MALI and REPUBLIC OF KOREA elected by the Economic and Social Council;²⁰ CANADA, GERMANY, JAPAN, NORWAY and SWEDEN selected by and from among the top 10 providers of assessed contributions to United Nations budgets and of voluntary contributions to United Nations funds, programmes and agencies, including a standing peacebuilding fund;²¹ and BANGLADESH, ETHIOPIA, INDIA, PAKISTAN and RWANDA selected by and from among the top 10 providers of military personnel and civilian police to United Nations missions.²²

At its 39th plenary meeting, on 5 December 2019, the General Assembly, on the proposal of its President, decided to postpone the date of recess of the seventy-fourth session of the Assembly from Monday, 16 December 2019, to Tuesday, 24 December 2019.

At the same meeting, the General Assembly, at the request of the Chair of the Fifth Committee, decided to extend the work of the Committee until Tuesday, 24 December 2019.

At its 52nd (resumed) plenary meeting, on 24 December 2019, the General Assembly, on the proposal of its President, decided to further postpone the date of recess of the seventy-fourth session of the Assembly from Tuesday, 24 December 2019, to Friday, 27 December 2019.

At the same meeting, the General Assembly, at the request of the Chair of the Fifth Committee, decided to further extend the work of the Committee until Friday, 27 December 2019.

74/503. Adoption of the agenda and allocation of agenda items

At its 2nd plenary meeting, on 20 September 2019, the General Assembly, on the recommendation of the General Committee as set forth in its first report,²⁷ adopted the agenda²⁸ and the allocation of agenda items²⁹ for the seventy-fourth session.

Also at the same meeting, the General Assembly, on the recommendation of the General Committee as set forth in its first report,³² by a recorded vote of 79 to 13, with 17 abstentions,³³ decided to include in the agenda of its seventy-fourth session an item entitled “The responsibility to protect and the prevention of genocide, war crimes, ethnic cleansing and crimes against humanity” under heading I (Organizational, administrative and other matters).

At its 19th plenary meeting, on 23 October 2019, the General Assembly, on the proposal of the Secretary-General,³⁴ having waived the relevant provisions of rule 40 of its rules of procedure, decided to include in the agenda of its seventy-fourth session an additional sub-item entitled “Appointment of members and alternate members of the United Nations Staff Pension Committee”, as sub-item (j) of agenda item 115 entitled “Appointments to fill vacancies in subsidiary organs and other appointments” under heading I (Organizational, administrative and other matters), and to allocate it to the Fifth Committee.

At its 52nd plenary meeting, on 19 December 2019, the General Assembly decided to consider directly in plenary meeting sub-item (b) entitled “International financial system and development” of agenda item 17 entitled “Macroeconomic policy questions”, under heading A (Promotion of sustained economic growth and sustainable development in accordance with the relevant resolutions of the General Assembly and recent United Nations conferences), and to proceed expeditiously with the consideration of a draft resolution.³⁵

At its 46th plenary meeting, on 12 December 2019, the General Assembly, on the recommendation of the First Committee,⁴² recalling its resolution 73/82 of 5 December 2018 on the report of the Disarmament Commission and its decision 52/492 of 8 September 1998 concerning the efficient functioning of the Commission; considering the role that the Disarmament Commission had been called upon to play and the contribution that it should make in examining and submitting recommendations on various problems in the field of disarmament and in promoting the implementation of the relevant decisions adopted by the General Assembly at its tenth special session; recalling in particular General Assembly resolution 45/62 B of 4 December 1990, in which it noted with satisfaction the adoption by consensus of a set of “Ways and means to enhance the functioning of the Disarmament Commission”,⁴³ and Assembly resolution 61/98 of 6 December 2006, which contained additional measures for improving the effectiveness of the methods of work of the Commission; reaffirming the mandate of the Disarmament Commission as the specialized, deliberative subsidiary body of the General Assembly that allowed for in-depth deliberations on specific disarmament issues, leading to the submission of concrete recommendations
