PRE-TRIAL CHAMBER I of the International Criminal Court (the "Chamber" and the "Court", respectively);

NOTING that, according to public information available to the Chamber,<sup>1</sup> Omar Al-Bashir, as President of Sudan, has been invited by the Government of Kenya to attend the celebrations for the promulgation of the new Kenyan Constitution scheduled to take place in Kenya on 27 August 2010;

NOTING the warrants of arrest against Omar Al-Bashir issued by the Chamber respectively on 4 March 2009 and 12 July 2010 which are yet to be executed;<sup>2</sup>

NOTING that the Republic of Kenya has a clear obligation to cooperate with the Court in relation to the enforcement of such warrants of arrest, which stems both from the United Nations Security Council Resolution 1593(2005)<sup>3</sup>, whereby the United Nations Security Council "urge[d] all States and concerned regional and other international organizations to cooperate fully" with the Court, and from article 87 of the Statute of the Court, to which the Republic of Kenya is a State Party;

CONSIDERING it appropriate to inform the Security Council of the United Nations as well as the Assembly of States Parties to the Rome Statute about the expected attendance of Omar Al-Bashir at the celebration scheduled for Friday 27 August in order for them to take any action they may deem appropriate, should such attendance be confirmed;

PRE-TRIAL CHAMBER I of the International Criminal Court (the "Chamber" and the "Court", respectively);

NOTING the "Registry's report on the recent visits of Omar Al Bashir to the Republic of Chad and the Republic of Kenya",<sup>1</sup> filed on 27 August 2010, whereby the Registrar, *inter alia*, informed the Chamber that, according to the information available, Omar Al Bashir had gone to N'Djamena in order to attend the summit of the Sahel-Saharan States on 21 July 2010, allegedly leaving Chad on 23 July 2010;

NOTING the warrants of arrest against Omar Al-Bashir issued by the Chamber respectively on 4 March 2009 and 12 July 2010 which are yet to be executed;<sup>2</sup>

NOTING that the Republic of Chad has an obligation to cooperate with the Court in relation to the enforcement of such warrants of arrest, which stems both from the United Nations Security Council Resolution 1593(2005)<sup>3</sup>, whereby the United Nations Security Council "urge[d] all States and concerned regional and other international organizations to cooperate fully" with the Court, and from article 87 of the Statute of the Court, to which the Republic of Chad is a State Party;

CONSIDERING it appropriate to inform the Security Council of the United Nations as well as the Assembly of States Parties to the Rome Statute about the recent visit of Omar Al-Bashir to the Republic of Chad, in order for them to take any action they may deem appropriate;
